May kindly see below placed letter no.1269/IX Kaushambi dated 30.11.2018 (at flag 'A') of Sri Pramod Kumar-I, the then District and Sessions Judge, Kaushambi presently posted as the District and Sessions Judge, Jhansi regarding his medical reimbursement claim amounting to Rs.15,000/- bearing countersignature of the technical examination authority for the amount of Rs.15,501/- being admissible for reimbursement, incurred over purchase of his spectacles on 19.08.2018 under prescription dated 13.06.2018 of Sanyukta Jila Chikitsalaya, Kaushambi.

The said medical claim has now been resubmitted to this Court vide aforesaid letter dated 30.11.2018 of Sri Pramod Kumar-I.

In this connection it is submitted that Rule 9(a) and 9(b) of the 'The Uttar Pradesh Government Servants (Medical Attendance) Rules 2011' issued vide notification no.2275/V-6-11-1082-87 dated 20.09.2011 read with 'The Uttar Pradesh Government Servants (Medical Attendance) (First Amendment) Rules 2014' issued vide notification no. 474/V-6-14-1082-87, dated 04.03.2014 are as quoted hereafter:

9.(a): "On the recommendation of the treating doctor and with the approval of the Medical Superintendent of the hospital, by whatever designation he may be known, the following artificial organs and appliances may be admissible:-

11. Spectacles (not more than once in three year)

(b): "The supply of the above artificial organs and appliances should be made on the written advice of the treating doctor indication the specification, make and model etc."

Further, the above quoted provisions are subject to the maximum limit of Rs.15,000/- as passed vide Hon'ble Court's Order dated 10.10.2015 quoted hereunder:-

"The claims for spectacles purchased up to maximum limit not more than Rs.15000.00 as fixed for the Hon'ble Judges, be made admissible ordinarily once in three years."

In this connection, it is further submitted that under the provisions contained in rule 20 of "The Uttar Pradesh Government Servants (Medical Attendance) (First Amendment) Rules, 2014", the sanctioning authority for working/ retired Government servants, are as mentioned below:-

Since the instant claim has been submitted by Sri Pramod Kumar-I, the then District and Sessions Judge, Kaushambi presently posted as the District and Sessions Judge, Jhansi while working in the capacity of Head of Office (of Kaushambi Judgeship), his medical reimbursement claim can be sanctioned under the above provisions, by an officer who is one rank senior i.e. the Head of Department viz. Hon'ble Mr. Justice Vikram Nath (nominated authority for sanction of medical reimbursement claims).


