May kindly see the letter dated 03.02.2011 of Sri Pramod Kumar, Additional District & Session Judge, Fatehpur through which he has sent attested copies of certificate of his and his child to this Court for grant of Personal Pay under voluntary family planning programme to him placed below at Flag 'A'.

It may be recalled that earlier Sri Pramod Kumar the then Additional District & Session Judge (F.T.C.) Firozabad sent an application dated 28.01.2008 to this Court and applied for personal pay under voluntary family planning programme. He had did not submit attested copy of birth certificate of his child as well as his date of birth certificate with application dated 21.01.2008.

On the aforesaid application dated 28.01.2008, a Court's letter No. 7472/IV- request to ask Sri Pramod Kumar, Additional District Judge (F.T.C.) Firozabad to send attested copy of birth certificates of his child and own to this court for necessary action.

In reply of Court's letter dated 04.06.2008 Sri Pramod Kumar through his letter dated 03.02.2011 has submitted attested copies of certificate ^{bearing date of birth} of his and his child to this Court for necessary action which is at Flag 'D' and 'E'

According to papers received from Sri Pramod Kumar dated 3.2.11 and 21.01.2008 papers available on his instant personal / Misc. file details of the claim are as under:-

1. His date of birth is 15.01.1960
2. His ~~present~~ age is 48 years as per declaration dated 28-01-2008.
3. He joined the service on 01.09.1987
4. He has only one Child vide declaration at flag 'B'
5. The age of his child is 17 years 6 months and his date of birth is 02.09.1990 vide certificate issued by Chief Executive and Secretary, Council for the Indian School Certificate Examinations, New Delhi, attested copy of certificate is at flag 'D'
6. He has not got the personal Pay under voluntary family planning programme vide declaration at flag 'C'
7. His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at flag 'B'
8. Neither any departmental enquiry is pending against Sri Pramod Kumar, Addl. District and Sessions Judge, Fatehpur nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer (Confidential-A) section at flag 'D' & 'F'

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79, dated 26.05.1980 and G.O. Pa.Ka. 2667/16-11-80-9/155/79, dated 11.06.1980 required declaration have been Sri Pramod Kumar, and same are at flag 'B' and 'C'

In this connection it is submitted that Sri Pramod Kumar, Addl. District and Sessions Judge, Fatehpur has fulfilled all the conditions as laid down in the aforesaid G.O.s for sanction of personal pay under voluntary family planning programme equal to one increment with effect from 02.09.2000 when he become entitled to the benefit
