May kindly see the letter, placed below at flag 'A', received from Sri Shaileshwar Nath Singh the then Additional District & Sessions Judge, presently posted as Spl. Judge (SC/ST, Pev. of Atroci Act), Siddharth Nagar regarding issuance of 'Identity Certificate' for obtaining Passport.

In his letter, Sri Singh has stated that there may be a possibility for him to visit abroad in future due to some need, therefore, he wants to obtain passport for himself for which 'Identity Certificate' is required from the Hon'ble Court as per Passport Rule. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Smt. Neetu Singh (Wife) and Ms. Nutan Patel (Daughter). He has, therefore, requested to kindly place his application before the Hon'ble Court for issuance of 'Identity Certificate' in his favour for obtaining passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Shaileshwar Nath Singh. His request is considerable, as he has submitted required details and papers in this connection.
