in this connection, it is submitted that earlier Sri Shaleshwer Nath Singh had submitted his movable & immovable property statement for the calendar year 2008 & 2009, through his letter dated 24-09-2010 (flagged 'A-1') which was not according to circular letter dated 13-05-2004. Thereafter he was asked to send his property statement for the calendar year 2003 and financial year 2004-05, 2005-06, 2006-07, 2007-08 2008-09 & 2009-10 vide court's letter dated 24-02-2011 (flagged 'C').

In reply of Court's letter dated 24-02-11 Sri Shaleshwer Nath Singh has sent letter dated 09-03-2011 (flagged 'A'), by which he has submitted the movable & immovable property statement of the calendar year 2003 and financial years 2004-05, 2005-06, 2006-07 & 2007-08, 2008-09 & 2009-10.

In this connection it is further submitted that Sri Shaleshwer Nath Singh had already submitted the statement of his property acquired/ held up to the calendar Year 2002 which has already been seen by Hon'ble Mr. Justice V. K. Chaturvedi, the then Administrative Judge Kanpur Denat Judgeship on 23-04-2003, submitted through office note dated 13-04-2003 at flag 'B'.

May, therefore, if approved, the statement for the calendar year 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 & 2009-10 of Sri Shaleshwer Nath Singh, Additional District & Session Judge, Etawah ^{be} laid before Hon'ble Mr. Justice Vinod Prasad, Administrative Judge, Etawah Judgeship for his Lordship's kind perusal and orders?
