May kindly see the letter, placed below at flag 'A', 'A-I' and 'A-II' received from Sri Shailesher Nath Singh, Additional District & Sessions Judge, Etawah <sup>Badam</sup> regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the calendar year 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 and 2009-10 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

The statements for the aforesaid financial years was previously submitted to Hon'ble Mr. Justice Vinod Prasad, the then Administrative Judge, Etawah Judgeship through office note dated 23-05-11 ( flagged 'AA'), but the file/ office note has been returned without Order. Thereafter he was asked to furnish some information vide Court's letters dated 10-03-2014 & 17-05-2014( flagged 'C' & 'C-I').

Now, Sri Shailesher Nath Singh has submitted required informations through his letter dated 08-07-2014 (flagged 'A-II').

In this connection, it is submitted that as per statement of movable and immovable property for the calendar year 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 and 2009-10 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the calendar year 2003 the income from salary is Rs.02,49,604/- and from this amount, Rs.32,714/- is deducted against GPF, Rs.1440/- against GIS, Rs.28,524/- against income Tax, Rs.3441/- against Rent and Rs.80,000/- deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.64,931/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.2,11,050/-. Thus, a sum of Rs.38,554/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the calendar year 2003.

However, it is pertinent to mention here that the his wife Smt. Neetu Singh is an Advocate and her annual income is about Rs.72,640/-.

(2) In the financial year 2004-05, the income from salary is

Rs.02,74,719/- and from this amount, Rs.29,116/- is deducted against GPF, Rs.1440/- against GIS, Rs.29,141/- against Income Tax, Rs.2077/- against Rent and Rs.70,000/- deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.40,725/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.1,79,499/-. Thus, a sum of Rs.95,220/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2004-05.

However, it is pertinent to mention here that the his wife Smt. Neetu Singh's annual income is about Rs.1,12,401/-.

(3) In the financial year 2005-06, the income from salary is Rs.05,06,035/- and from this amount, Rs.1,42,209/- is deducted against GPF, Rs.1440/- against GIS, Rs.63,049/- against Income Tax and Rs.70,000/- (including interest) deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.1,27,038/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.4,03,736/-. Thus, a sum of Rs.01,02,299/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2005-06.

However, it is pertinent to mention here that the his wife Smt. Neetu Singh's annual income is about Rs.1,99,566/-.

(04) In the financial year 2006-07, the income from salary is Rs.04,45,086/- and from this amount, Rs.46,541/- is deducted against GPF, Rs.1440/- against GIS, Rs.39,031/- against Income Tax, and Rs.70,000/- deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs1,45,899/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.3,02,911/-. Thus, a sum of Rs.1,42,174/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2006-07.

However, it is pertinent to mention here that his wife Smt. Neetu Singh's annual income is about Rs.1,51,677/-.

(5) In the financial year 2007-08, the income from salary is Rs.04,90,799/- and his wife Smt. Neetu Singh's annual income from Advocate is about Rs.2,05,864/-. Total income is Rs. 6,96,663/-, and from this amount, Rs.1,15,637/- is deducted against GPF, Rs.1440/- against GIS, Rs.53,264/- against Income Tax and Rs.70,000/- (including interest) deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs1,00,273/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.3,40,614/-. Thus, a sum of Rs.1,50,185/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2007-08.

(06) In the financial year 2008-09, the income from salary is the income from salary is Rs.05,20,502/- and from this amount, Rs.1,02,320/- is deducted against GPF, Rs.1440/- against GIS, Rs.40,276/- against Income Tax, and Rs.70,000/- deposited in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.66,054/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.2,80,090/-. Thus, a sum of Rs.2,40,412/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2008-09.

However, it is pertinent to mention here that the his wife Smt. Neetu Singh's annual income is about Rs.1,60,071/-.

(07) In the financial year 2009-10, the income from salary is the income from salary is Rs.06,35,632/- and from this amount, Rs.1,23,686/- is deducted against GPF, Rs.1440/- against GIS, Rs.55,023/- against Income Tax, and Rs.70,000/- (including interest) deposited in his PPF account in this year this. As such, total deductions/repayment/savings/ investment is Rs.2,50,149/-. The balance of his saving bank account (s) is reduced to Rs.1,79,142/- from its previous year's balance. Thus, a sum of Rs.5,64,625 was therefore available with him to meet out the household expenditure of his family

consisting of four members in whole of the financial year 2009-10.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the property statement for the calendar year 2003 in the beginning of next calendar year up to 20, January. He has submitted the same through letter dated 09-03-2011 and as such, there is a lot of delay in submitting the said statements. The property statement for the years 2004-05 & 2005-06 in its next financial year i. e. in 2006-07 up to March 2007. He has submitted the same through letter dated 09-03-2011 and as such, there is a lot of delay in submitting the same. The property statement for the year 2006-07 & 2007-08 in its next financial year i. e. in 2008-09 up to March 2009. He has submitted the same through letter dated 09-03-2011 and as such, there is ~~some~~ delay in submitting the same statements. The property statement for the year 2008-09 & 2009-10 in its next financial year i. e. in 2010-11 up to March 2011. He has submitted the same through letter dated 09-03-2011 and as such, there is no delay in submitting the same statements.

May, therefore, if approved, the property statements for the calendar year 2003 and financial years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 and 2009-10 alongwith letters dated 09-03-2011, 05-04-2014 and 08-07-2014 (flagged 'A', 'A-I' and 'A-II') of Sri Shailesher Nath Singh, Additional District & Sessions Judge, Budaun be laid before Hon'ble Mr. Justice Dinesh Maheshwari, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
