May kindly see the letter, placed below at flag 'A', received from Sri Shaileshwar Nath Singh, Special Judge (SC/ST, Pev. Of Atroci Act), Budaun regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2010-11, the income from salary is Rs.8,22,371/- and from this amount, Rs.1,440/- is deducted against GIS, Rs.2,07,740/- against GPF, Rs.80,828/- against Income Tax, Rs.5,351/- against Premium of LIC policies, and Rs.70,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs. 2,73,044/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.6,38,403/-. Thus, a sum of Rs.1,83,968/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

It is pertinent to mention here that his wife Mrs. Neetu Singh is an advocate and her annual income is about Rs.1,91,953/-.

In the financial year 2011-12, the income from salary is Rs.24,18,921/-and from this amount, Rs.3,960/- is deducted against GIS, Rs.7,06,450/ against GPF, Rs.5,46,488/- against Income Tax, Rs.5,351/- against Premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs. 7,05,745/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.20,67,994/-. Thus, a sum of Rs.3,50,927/- was therefore available with him to meet out the household expenditure of his family consisting of the financial year.

His wife's annual income is about Rs. 2,17,463/-.

(3) In the financial year 2012-13, the income from salary is Rs.12,69,786/- and income from sale of Land is Rs. 10,50,000/-. Thus the total income is Rs. 23,19,786/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.2,79,339/- against GPF, Rs.1,83,274/- against Income Tax, Rs.5,351/- against Premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.5,72,764/-. The balance of his savings bank account(s) reduced for Rs. 3,17,868/- this financial year. Thus, a sum of Rs. 20,64,890/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.

His wife's annual income is about Rs. 3,77,090/-.

In the financial year 2013-14, the income from salary is Rs.15,71,641/-and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,58,494/-against GPF, Rs.2,78,646/- against Income Tax, Rs.5,351/- against Premium of LIC policies and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs. 7,47,016/- this financial year As such, total deductions/ repayment/ savings/ investment is Rs.12,94,307/-. Thus, a sum of Rs. 2,77,334/- was therefore available with him to meet out the household expenditure of his family consisting of the members in whole of the financial year.

His wife's annual income is about Rs. 3,62,199/-.

In this connection it is submitted that Sri Shaileshwar Nath Singh has already submitted his property statement upto the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Bharat Bhushan, Administrative Judge, Budaun on 04.08.2015 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2010-11 & 2011-12 in its next financial year i.e., 2012-13 upto march 2013, and 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the movable and immovable property statement for the financial year 2010-11, 2011-12, 2012-13 &

2013-14 vide his letter dated 13.04.2015 (at flag 'A'). As such, there is delay in submitting the aforesaid statements.

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 alongwith letter dated 13-04-2015 (flagged 'A") of Sri Shaileshwar Nath Singh, Special Judge (SC/ST, Pev. Of Atroci Act), Budaun be laid before Hon'ble Mr. Justice Bharat Bhushan, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
