- 3. That the withdrawal column in G.P.Fund Pass-Book for each financial year has been verified by the concerned Drawing and Disbursing Officer.
- 4. That the G.P.Fund account for each financial year has been closed under signature and seal of concerned Drawing and Disbursing Officer.
- 5. That the Treasury Voucher No. and date against each amount of G.P.Fund has been mentioned in Pass-Book.
- 6. That the Reconciliation Certificate, issued by the Office of the A.G. (A.&E.)-II, U.P., Allahabad is required for sanction of 90% G.P. Fund.
- 7. That an undertaking of the Officer concerned regarding in case of over payment, if any reported later on, the same shall be refunded alongwith the interest, immediately and signature of the Officer shall be attested by the Drawing and Disbursing Officer of the Judgeship.
