May kindly see the letter bearing No.90/Siddharth Nagar dated 22.12.2016 (at flag 'A') of the Drawing Disbursing Officer, District Court, Siddharth Nagar, for making payment of 90% amount of Sri Shaileshwar Nath Singh, Compulsorily Retired Additional District Judge, Siddharth Nagar from his G.P. Fund Account No.L.J.U.-18583. Sri Shaileshwar Nath Singh was retired Compulsorily on 03.05.2016 by the Government of U.P. Vide its Office Memorandum bearing No.121/II-4-2016-26(2)/2016, Lucknow dated 03 May, 2016 (at flag 'B').

The District Judge, Siddharth Nagar has submitted original Pass-Book of G.P.Fund Account No.L.J.U.-18583 (at flag 'C') of Sri Shaileshwar Nath Singh along with three sets of application in Form 425-A under the signature and seal of Drawing Disbursing Officer District Court, Siddharth Nagar as well as Senior Treasury Officer, Siddharth Nagar together with three sets of calculation sheets from the financial year 2011-2012 to 2016-2017 (at flags 'D', 'E', 'F', 'G', 'H' and 'I') and original Reconciliation Certificate, issued by the A.G.(A.&E.)-II, U.P., Allahabad on 09.08.2016 (at flag 'J') of Sri Shaileshwar Nath Singh, Compulsorily Retired Additional District Judge, Siddharth Nagar. The District Judge, Siddharth Nagar has requested the Court, for making payment of 90% amount of G.P. Fund of Sri Shaileshwar Nath Singh from his G.P. Fund Account No.L.J.U.-18583.

As per Reconciliation Certificate issued from the A.G.(A.&E.)-II, U.P., Allahabad a total of Rs.43,18,016/- is available as closing balance of Financial Year 2014-2015 in G.P.F. Account No.L.J.U.-18583 whereas as per G.P.F. Pass Book closing balance for Financial Year 2014-2015 is Rs.42,33,672/-. Further, from perusal of G.P.F. pass-book and calculation sheets of the Financial Year 2015-2016 and 2016-2017, it is evident that the following amount was credited in respective manner :

Going further, it is submitted that out of the total amount of Rs. Rs.48,30,350/-, the Drawing Disbursing Officer District Court, Siddharth Nagar has recommended for sanction of Rs.43,47,315/- only in favour of Sri Shaileshwar Nath Singh as 90% amount of his G.P.Fund in the Drawing and Disbursing Part

(at flag 'K') of his application in Form 425-A. The Senior Treasury Officer, Siddharth Nagar has also recommended, for making payment of Rs.43,47,315/- only at the place of Checking Accounts Authority Part of his application in Form 425-A after checking calculation sheets of G.P. Fund of Sri Singh.

In this context it is submitted that the payment of 90% of G.P.Fund amount of Retiring/Retired Judicial Officer is to be sanctioned by this Court in terms of G.O.No.Sa-4-A.G.-57/X-84-510-84, dated 26.12.1984 and General Provident Fund (Uttar Pradesh)(Second Amendment) Rules, 2000 on submission of Reconciliation Certificate, issued by the office of the A.G.(A.&E.)-II, U.P., Allahabad, G.P. Fund Pass-Book of Retiring/Retired Judicial Officer prepared at least from the financial year 1985-86 up to the month of his retirement and calculation sheets of his G.P.Fund of the current financial year (up to the month of retirement) as well as five preceding financial years to this Court by the Drawing and Disbursing Officer of concerned Establishment/Judgeship with his recommendation and recommendation of the Chief/Senior Treasury Officer of the District, for payment of 90% of G.P.Fund amount to the Retiring/Retired Judicial Officer.

After perusal of G.P. Fund Pass-Book of Sri Shaileshwar Nath Singh, it appears that Final Withdrawal and Temporary Advance are nil.

In view of the facts, mentioned above, if approved by the Registrar (Judicial) (Budget), the file may be laid before Hon'ble Mr. Justice Manoj Misra "Nominated Judge for disposal of the matters of Judicial Officers for payment of 90% amount of G.P.Fund," for His Lordship's kind perusal and order to the effect that a sum of Rs.43,47,315/-(Forty Three Lacs Forty Seven Thousand Three Hundred and Fifteen) only may be sanctioned to Sri Shaileshwar Nath Singh, Compulsorily Retired Additional District Judge, Siddharth Nagar as 90% amount of the total balance available in his G.P. Fund Account No.L.J.U.-18583, up till the date of his retirement from service i.e. 03.05.2016, subject to the condition that in case of over payment, if any, reported later on, by office of the Accountant General (A.&E.)-II, U.P., Allahabad, he shall refund the excess payment along with amount of interest accrued thereon in lump sum within a month?

His Lordship may also be requested kindly to sign the draft sanction order, placed below, at the place cross marked with red pen?







**ORDER**

In terms of G.O.No.Sa.-4-A.G.-57/X-84-510-84, dated 26.12.1984 and General Provident Fund (Uttar Pradesh) (Second Amendment), Rules 2000 a sum of Rs.43,47,315/-(Forty Three Lacs Forty Seven Thousand Three Hundred and Fifteen) only may be sanctioned to Sri Shaileshwar Nath Singh, Compulsorily Retired Additional District Judge, Siddharth Nagar as 90% of the total amount of Rs.48,30,350/-(Forty Eight Lacs Thirty Thousand Three Hundred and Fifty) only, available in his G.P. Fund Account No.L.J.U.-18583, up till the date of his retirement from service i.e.03.05.2016, as per his Reconciliation Certificate, issued by the A.G.(A.&E.)-II, U.P., Allahabad as well as G.P. Fund Pass-Book and as per calculation sheets of his G.P. Fund from the Financial Year 2011-2012 to 2016-2017 subject to the condition that in case of over payment, if any, reported later on, by office of the Accountant General (A.&E.)-II, U.P., Allahabad, he shall refund the excess payment along with amount of interest accrued thereon in lump sum within a month.
