May kindly see the letters, placed below at flag 'A' & 'A-1', re Satish Kumar, Addl. District Judge, F.T.C., Pilibhit, by which he has requested the Court to issue 'No Objection Certificate' in his favour for obtaining passport.

In his letters, Sri. Satish Kumar has stated that the brother of his wife Dr. Guru Saran is residing in London (U.K.) with his family and blessed with a baby boy recently and organized a family function there. He also wishes to attend the function there with his family, for that a Passport will be required. Therefore, he intends to apply for Passport, for which 'No-Objection Certificate' of the Court is essential. He also states that: -

- (1) There will be no possibility of arising embarrassing position before the Govt. of India or the Govt. of U.P., due to his visit to London.
- (2) Request for issue of 'No-objection Certificate' for obtaining a Passport was never refused to him or made earlier.
- (3) He never visited any foreign country earlier.
- (4) His dependents are his wife Smt. Suman Bala and two daughters Km. Vanshika Attri and Km. Anshika Attri.

In this connection, it is submitted that 'No-objection Certificate' (now said as 'Identity Certificate' as per new proforma issued by the Passport department) for obtaining a Passport may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). It is further submitted that as per reports, placed below, no vigilance / departmental enquiry is pending against Sri. Satish Kumar. He may be granted 'No-objection Certificate' / Identity Certificate' from this Court, as requested.

May, therefore, if approved by Hon'ble Ms. Justice Bharati Sapru, Administrative Judge, Pilibhit Judgeship, the 'Identity Certificate' at flag 'C' be issued, in duplicate, in favour of Satish Kumar, Addl. District Judge, F.T.C., Pilibhit for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
