May kindly see the letter dated 01.02.2016 at flag 'Z', received from Sri Satish Kumar-II, Spl. Judge (E.C. Act), Jhansi regarding postponement of his visit to Dubai (U.A.E.) alongwith his family members proposed from 10.01.2016 to 14.01.2016 and for grant of permission to visit Dubai (U.A.E.) alongwith his family members in the month of March-April 2016 now.

In his letter, Sri Satish has stated that on his earlier request to visit Dubai (U.A.E.) alongwith his family members from 10.01.2016 to 14.01.2016, the Hon'ble Court had been pleased to grant him permission for the said purpose vide letter no. 252/ IV- 2464/ Admin (A-4)/ dated 05.01.2016 (flag 'X'). Unfortunately, his younger daughter's passport had expired so he cancelled his aforesaid abroad visit which was scheduled from 10.01.2016 to 14.01.2016. Now he has got her new passport and again wishes to visit Dubai (U.A.E.) alongwith his family members in the month of March-April 2016. He has, therefore, requested to kindly place his application before the Hon'ble Court for granting him permission to visit Dubai (U.A.E.) alongwith his family members in the month of March-April 2016.

In this connection, it is submitted that on his earlier request dated 05.12.2015 (flag 'A') for grant of permission to visit Dubai (U.A.E.) alongwith his family members in January 2016 i.e. from 10.01.2016 to 14.01.2016, Sri Satish was granted permission, as requested, vide Court's order dated 04.01.2016 (flag 'Y') of Hon'ble the Administrative Judge, Jhansi Judgeship. Now, Sri Satish has submitted that he had not been able to visit Dubai (U.A.E.) on the proposed date as his younger daughter's passport got expired at that time and now again wants to visit Dubai (U.A.E.) in the month of March-April 2016 as he got her new passport prepared now, therefore he has requested for grant of permission for the same. His visit is purely personal and as he has also submitted genuine reason for delay in his proposed visit, his request may be considered.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice R. D. Khare, Administrative Judge, Jhansi Judgeship, Sri Satish Kumar-II, Spl. Judge (E.C. Act), Jhansi may now be granted permission to visit Dubai (U.A.E.) along with his family for tourism purpose only in the month of March-April 2016, instead in the month of January 2016 i.e. from 10.01.2016 to 14.01.2016, as earlier approved, subject to the condition that proper charge of records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?
