May kindly see the letter, placed below at flag 'A', received from Sri Satish Kumar-II, Special Judge (E.C. Act), Jhansi regarding grant of permission to visit Dubai for a period of 5 days i.e. from 10.01.2016 to 14.01.2016.

In his letter, Sri Satish Kumar has stated that he along with his wife and two daughters want to visit Dubai (U.A.E.) in January 2016 i.e. from 10.01.2016 to 14.01.2016. The purpose of visit is tourism only as his children are eager to fulfill their desire to visit Dubai. The total expense of his proposed visit will be around Rs. 2,00,000/- which would be meet out from the salary savings account of the officer & his wife. It is also pertinent to mention here that the wife of the officer i.e. Mrs. Suman Bala is working in Canara Bank & draws Rs. 2,30,000/- as her annual income. He has also enclosed copy of his passbook (copy is at flag 'B', showing balance of Rs. 3,19,142/-) & copy of statement of his wife's account (flagged 'B-1') Copy of passports of himself, his wife Smt. Suman Bala and two daughters Km. Vanshika Attri & Km. Anshika Attri are nos. J 1412789, J 3022204, K 4884080 & J 1410464 respectively (flagged 'C'). He has further stated that :-

1. There is no possibility of arising embarrassing position before the Government of India or the Government of U.P., due to his said abroad visit.
2. Such type of request was never refused to him.
3. He has never visited any foreign country earlier.

He has, therefore, requested for grant of permission to visit Dubai (U.A.E.) for a period of 5 days i.e. from 10.01.2016 to 14.01.2016 along with his family.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'D'). As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Satish Kumar-II. Earlier, he had been issued 'Identity Certificate' dated 30.01.2010 (copy is at flag 'E') for obtaining passport as per approval dated 25.01.2010 of the Administrative Judge, Ambedkar Nagar (flagged 'E-1'). Now, as Sri Satish Kumar has requested for grant of permission to visit Dubai (U.A.E.) along with his family for tourism purpose only, his visit is purely personal. He has also submitted required details of his visit, his request may be considered.

A' Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice R. D. Khare, Administrative Judge, Jhansi for His Lordship kind perusal and if His Lordship approves, Sri Satish Kumar-II, Special Judge (E.C. Act), Jhansi may be granted permission to visit Dubai (U.A.E.)
