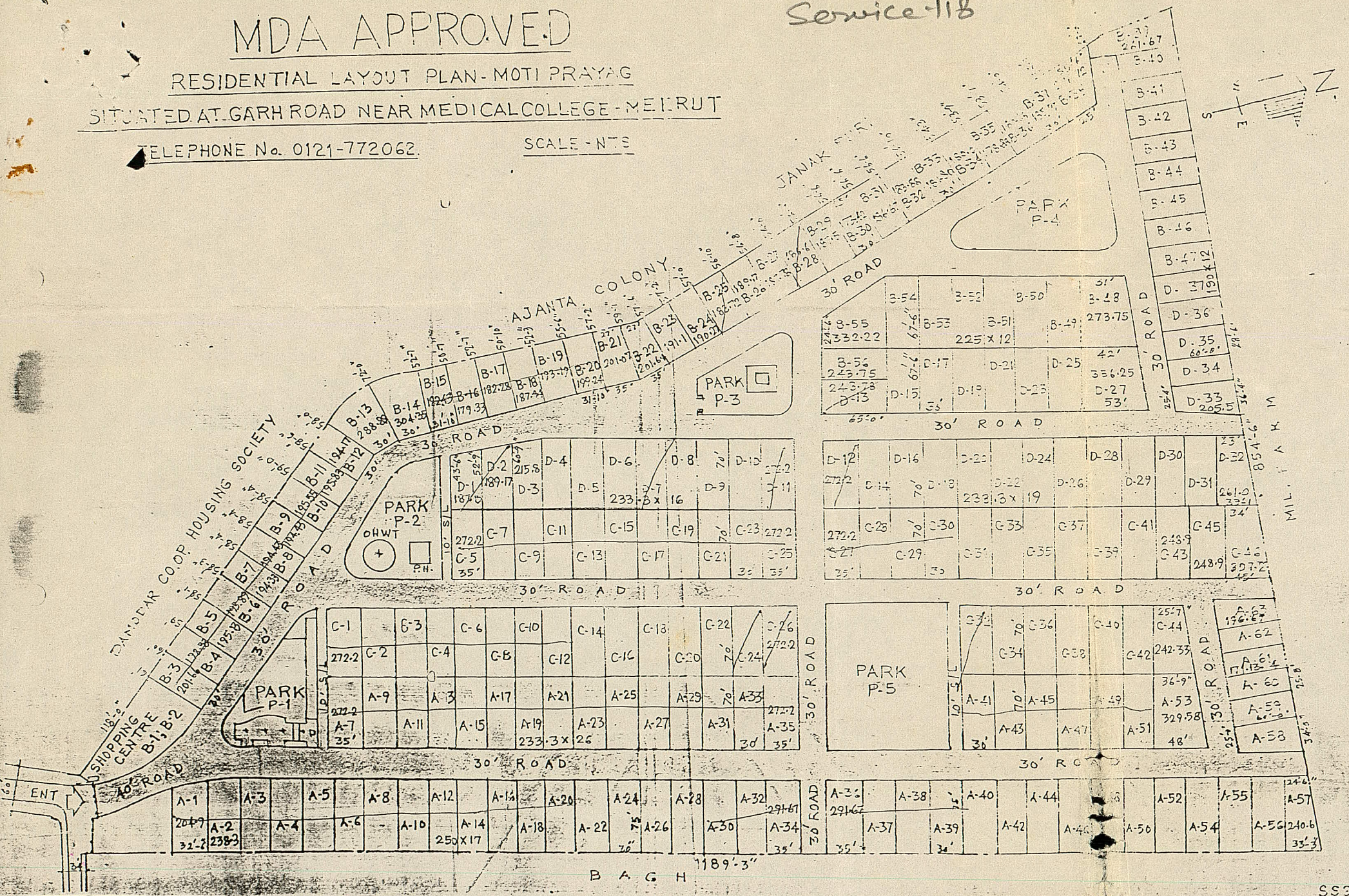
RESIDENTIAL LAYOUT PLAN - MOTI PRAYAG
