May kindly see the letters dated 28.3.17 and 9.6.17 (at flag 'A' and 'A-1') of Sri Gulab Singh, Additional District and Sessions Judge/Special Judge(SC/ST Act), Unnao by which he has submitted his movable and immovable property statements for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2010-11, Sri Singh's income from Salary and other Sources is Rs.15,34,986/- (Rs.9,69,391/- from Salary and Rs.5,65,625/- from maturity of FDR) from this amount, he has paid Rs.1,59,465/- against GPF, Rs.4220/- against GIS, Rs.1,08,683/- against Income Tax, Rs.70,000/- against PPF, Rs.10,548/- against LIC and Rs.7,75,000/- against STDR. As such, total deductions /Savings/investment is Rs.11,27,916/-. The balance of his Saving Bank Account(s) decreased for Rs.18,935/- this year. Thus a sum of Rs.4,02,6005/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.

(2) In the statement of movable and immovable property for the financial year 2011-12, Sri Singh's income from Salary is Rs.22,88,526/- from this amount, he has paid Rs.467,513/- against GPF, Rs.4,400/- against GIS, Rs.4,96,436/- against Income Tax, Rs.1,00,000/- against PPF, Rs.10,548/- against LIC and Rs.1,49,000/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.3,508/- this year. As such, total deductions /Savings/investment is Rs.12,31,405/-. Thus a sum of Rs.10,57,121/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.

(3) In the statement of movable and immovable property for the financial year 2012-13, Sri Singh's income from Salary is Rs.14,26,960/ from this amount, he has paid Rs.1,52,972/- against GPF, Rs.4,800/- against GIS, Rs.1,65,360/- against Income Tax, Rs.1,00,000/- against PPF, Rs.10,548/- against LIC and Rs.1,77,000/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.3,14,037/- this year. As such, total deductions /Savings/investment is Rs.9,24,717/-. Thus a sum of

Rs.5,02,243/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(4) In the statement of movable and immovable property for the financial year 2013-14, Sri Singh's income from Salary is Rs.11,83,241/ from this amount, he has paid Rs.3,11,725/- against GPF, Rs.4,000/- against GIS, Rs.1,63,000/- against Income Tax, Rs.1,00,000/- against PPF, Rs.10,548/- against LIC and Rs.2,40,000/- towards car loan. As such, total deductions /Savings/investment is Rs.8,29,273/-. The balance of his Saving Bank Account(s) decreased for Rs.3,23,130/- this year. Thus a sum of Rs.6,77,098/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

(5) In the statement of movable and immovable property for the financial year 2014-15, Sri Singh's income from Salary is Rs.20,25,788/ from this amount, he has paid Rs.3,29,583/- against GPF, Rs.52,000/- against GIS, Rs.2,97,100/- against Income Tax, Rs.1,50,000/- against PPF, Rs.10,548/- against LIC and Rs.90,148/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.3,22,670/- this year. As such, total deductions /Savings/investment is Rs.12,05,249/-. Thus a sum of Rs.8,20,539/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(6) In the statement of movable and immovable property for the financial year 2015-16, Sri Singh's income from Salary is Rs.16,93,727/ from this amount, he has paid Rs.3,25,630/- against GPF, Rs.48,000/- against GIS, Rs.2,80,800/- against Income Tax, Rs.1,50,000/- against PPF, Rs.10,548/- against LIC. As such, total deductions /Savings/investment is Rs.7,71,778/-. The balance of his Saving Bank Account(s) decreased for Rs.1,86,432/- this year. Thus a sum of Rs.11,08,381/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 28.3.17 (flag 'A'). The property statements for the financial 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13, property statements for the financial 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15 and property statements for the financial 2014-15 and 2015-16

was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17 . As such there is delay in submitting the Property statement for the financial year 2010-11, 2011-12, 2012-13 and 2013-14 from the part of the officer for which officer has stated that inadvertently and due to confusion, he was unable to submit the same in due time for which he has regretted.

In this connection, it is submitted that Sri Singh has already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Hamirpur Judgeship on 4.7.11 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 of Sri Gulab Singh, Additional District and Sessions Judge/Special Judge(SC/ST Act), Unnao may kindly be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Unnao Judgeship for His Lordship's kind perusal and orders ?
