वित्तोप हस्त पुस्तिका खण्ड-5, भाग-1 के पैराग्राफ 246 मण्डित राजाशा  
 संख्या- बी-3-511 (6) 745-2003 = 20 (12) 72001 = मौलिक  
 दिनांक 26-02-09 के अन्तर्गत श्री अशोक कुमार यादव, अपर मुख्य  
 - - - - - मापिक - कक्षाधिकारी - कानपुर - देहात - - - - -  
 को रु 100,000/- - - - - - अस्सी हजार मात्र - का अग्रिम मोटर कार  
 खरीदने के लिए निम्नलिखित शर्तों के अधीन स्वीकार किया जाता है।

1. स्वीकृति की तिथि में एक माह की मध्य मीमा के अन्दर अग्रिम को धनराशि  
 उस मध्य तक नहीं निकालनी चाहिए जबकि उपरोक्त वास्तव में व्यय करने की  
 आवश्यकता न हो। उसके तुरन्त बाद मोटर कार क्रय कर ले जाय अन्यथा आदेश  
 रद्द कर दिया जायेगा।

2. अग्रिम का अग्रिम आहरित करने के लिये तब प्रस्तुत करने के पूर्व एक अनुबन्ध  
 पत्र फार्म नं० 25-ए पर भर कर मोधे रूप न्यायालय को भेजा जाय। तदुपरान्त  
 मोटर कार क्रय किया जाय और अनुबन्ध पत्र की तिथि में एक माह के अन्दर फार्म  
 25 पर बन्धक पत्र भर कर उसके प्रत्येक पृष्ठ पर अपने हस्ताक्षर करके न्यायालय को  
 भेजा जाय।

3. यदि मोटर कार का वास्तविक मूल्य अग्रिम को धनराशि में कम हो तो बड़ी  
 हुई धनराशि शीघ्र कोषागार में वापस कर दी जाय।

4. अग्रिम पर अनन्तकाल से - - - - - 18.5 - - - - - प्रतिशत साधारण ब्याज लिया  
 जायेगा किन्तु निम्नलिखित रूप में अण/ब्याज के प्रतिदान/भुगतान होने पर ब्याज में  
 3.5 प्रतिशत की छूट दी जायेगी। ब्याज की जो दरें अंतिम रूप में निर्धारित होंगी  
 वह अग्रिमों को मान्य होंगी।

5. वित्तोप हस्त पुस्तिका खण्ड 5 भाग एक के पैराग्राफ 245 (डो) में दिये गये  
 नियमों के अनुसार अग्रिम को कटौती श्री - - - - - यादव - - - - - के वेतन से  
 - - - - - 96 - - - - - मापिक किस्तों में रु - - - - - 0301 - - - - - को दर में वसूल की जायेगी, निम्न  
 अन्तिम किस्त रु - - - - - 1150 - - - - - की होगी। बूलधन को अदायगी के तुरन्त बाद ब्याज  
 की किस्तों को अदायगी को जायेगी।

6. अग्रिम का प्रयोग किराया क्रय पद्धति के आधार पर वा किस्तों पर मोटर कार  
 खरीदने में नहीं किया जायेगा।





7. मोटर कार खरीदने जाने के एक माह के भीतर उसका कम्प्रेडिन्सव इन्श्योरेंस करा दिया जाय और सम्बन्धित लोमा पालिसी का नवीनीकरण कराकर उस समय चालू रहा जाय जब तक अग्रिम पूर्ण रूप से भुगतान न कर दिया जाय। लोमे के माध्यम में लोमा पालिसी या अन्य प्रमाणक मोटर कार मूल्य के प्रमाणक तथा बचोई धनराशि यदि कोई हो तो शासन को लौटाने की तिथि की सूचना के साथ न्यायालय को भेजी जाय।

8. शासन/न्यायालय द्वारा अपेक्षा किये जाने पर अथवा स्वैच्छिक सेवा निवृत्ति पर दर्शाये शेष धनराशि ब्याज सहित एक मुश्त में देय होगी।

इस सम्बन्ध में हुए व्यव चालू वित्तीय वर्ष 2001-2002 के आ-व्ययक में वित्त विभाग को अनुदान संख्या 61 के अन्तर्गत लेखा शीर्षक-7610-सरकारो कर्मचारियों को कर्म-भागीनेतर-202-मोटर वाहन का क्रय करने के लिये अग्रिम-03-राज्य कर्मचारियोंको मोटर वाहन क्रय करने के लिये अग्रिम-30 निवेश/भ्रण के नामे डाला जाना चाहिये।

May kindly see the letter placed below at Flag 'A' received from Sn Ashok Kumar Yadav, Addl. C.J.M., Kanpur - Dehat, regarding grant of four months time to utilise the amount of motor car advance, sanctioned to him.

In the instant letter Sri yadav has stated that the Court has been pleased to sanction him a sum of Rs. 80,000/- as motor car advance vide Court's letter no. 4805 / Vr-1529 / Admin(A) / dt. 23.3.2002 and the amount withdrawn by him. He has further stated that a good car (old or new) is not available to him with the aforesaid amount and at present, he is also not in a position to arrange additional money for purchase of a car, as he is spending Rs. 6500/- per month on a private rented house. He is anticipating re-embursement / sanction of H.R.A. in near future and therefore, he has requested the Court to grant him four months time to purchase a car from the amount, sanctioned to him.

In this connection, it is submitted that a sum of Rs. 80,000/- was sanctioned to Sri Ashok Kumar yadav, as motor car advance vide Court's order dated 23.3.2002 (Flagged 'B'). Under the financial Rules, the car must be purchased within one month from the date of withdrawal of the amount. It is also noteworthy here that in such type of request two or three months time were granted to some officers once or twice, as the case may be.

May kindly see the letter placed below at flag 'A' received from Sri Ashok Kumar Yadav, Addl. C.J.M., Kanpur-Dehat, regarding grant of four months time to utilise the amount of motor car advance, sanctioned to him.

In the instant letter Sri yadav has stated that the Court has been pleased to grant him three months time to utilise the amount of motor car advance, vide Court's letter no. 9626/IV-2529/Admin(A)/dt. 19.7.2002. He has further stated that he has submitted his application to the District Judge Kanpur-Dehat for withdrawal money from his G.P. Fund Account and that he is also making arrangement for money, which can take some time, therefore, he has requested the Court to grant him four months more time to purchase a car from the amount, sanctioned to him.

In this connection it is submitted that a sum of Rs. 00,000/- was sanctioned to Sri Ashok Kumar yadav, as motor car advance vide Court's order dated 23.3.2002 (flagged 'B'), under the financial Rule, the car must be purchased within one month from the date of withdrawal of the amount but Sri yadav ~~fail~~ to do so. This is also noteworthy here that earlier vide Court's order dated 9.7.2002 (flag 'C') granted three months time for purchase of car. Now he has again requested the Court to grant him four months more time to utilise the amount of motor car advance for purchasing of car, which is in the discretion of the sanctioning authority.

In view of the facts mentioned above, if approved, the file may be laid before the learned Registrar General for kind perusal and orders?

Sri Ashok Kumar Yadav, Addl. Chief Judicial Magistrate, Kanpur Dehat was sanctioned Motor Car advance of Rs. 80,000/- by this Court vide Court's order dated 23.3.2002 (**Flagged 'B'**). Under the financial Rule, the car was to be purchased within one month from the date of withdrawal of the amount, but Sri Yadav fail to do so.

It is noteworthy to mention here that earlier vide Court's order dated 9.7.2002 (**Flagged 'C'**), three months time for purchase of Car was granted to him.

He has further stated that he could not purchased the Car because he has applied for withdrawal of money from his G. P. ~~K~~ Fund Account from the District Judge, Kanpur Dehat and he has also making arrangement for money which can take some time. Now Sri Yadav has again requested this Court to grant four months more time to utilize the amount of Motor Car advance for purchase of Car which is in the discretion of Sanctioning Authority.
