May kindly see the D.O. letter, placed below at flag 'A', received from the Registrar, High Court, Lucknow Bench, Lucknow, by which he has sent letter dated 25.06.2007 (flagged 'A-1') of Sri. Ashok Kumar Yadav, A.D.J., F.T.C., Shrawasti at Bhinga for grant of permission to reside at Bahraich and to attend the Court daily at Shrawasti after performing journey from Bahraich every day i.e. to leave the place of posting every day.

In his letter, Sri Yadav has stated, that he has been transferred from Jaunpur to Shrawasti at Bhinga and he has taken over charge at Shrawasti on 07.06.2007, that his daughter Arpita Yadav, aged about 12 years is suffering from prolonged headache and her treatment was done in S.G.P.G.I., Lucknow and in Varanasi, but now there is no medical facility at Shrawasti and it is also very difficult to travel frequently to another city for her treatment. Besides this, she had studied from English medium school and passed class 7 from St. Patrick School Jaunpur, that his son Sushil Yadav passed Intermediate in the year 2006 from St. Johns School, Jaunpur from Science side, that there is no medical and educational facilities at Shrawasti for his children and if he will reside at Shrawasti with his family, his children will face adverse effect. If he will be permitted to reside at Bahraich, which is 40 kms. far from Shrawasti, he will attend the Court well in time and also will be able to give proper medical & educational facilities to his family. He has therefore, requested the Court to accord him permission to reside at Bahraich.

In this connection, it is submitted that In the instant case, the officer is requesting to reside at Bahraich and to attend the Court daily at Shrawasti after performing journey from Bahraich every day i.e. to leave the place of posting every day on the grounds, mentioned above, and acceptance of his request is on the discretion of the Hon'ble Administrative Judge of the judgeship as per prevailing practice.
