May kindly see the letter dated 8.4.15 (at flag 'A') of Sri Kali Charan-II, Additional District and Sessions Judge, Moradabad by which he has submitted his property statements for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Sri Kali Charan's total gross Income from Salary and other Sources is Rs.14,73,782/- from this amount, he has paid Rs.1,66,485/- against GPF, Rs.4800/- against GIS, Rs.1,63,460/- against Income Tax, Rs.1,00,000/- against PPF, Rs.15,000/- against Mutual fund (SIP), Rs.26,524/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.6,53,644/-. As such, total deductions /Savings/investment is Rs.11,29,913/-. Thus a sum of Rs.3,43,869/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Sri Kali Charan's total gross Income from Salary and other Sources is Rs.15,66,435/- from this amount, he has paid Rs.2,01,055/- against GPF, Rs.4800/- against GIS, Rs.2,41,685/- against Income Tax, Rs.1,00,000/- against PPF, Rs.60,000/- against Mutual fund (SIP), Rs.26,524/- against LIC, Rs.4,00,000/- against FDR. The balance of his Saving Bank Account(s) enhanced for Rs.24,007/-. As such, total deductions /Savings/investment is Rs.10,58,071/-. Thus a sum of Rs.5,08,364/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 8.4.15 (flag 'A'). The Property Statements for the financial years 2013-14 and 2014-15 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is Some delay in submitting the aforesaid Property statement from the part of the officer.

In this connection, it is submitted that Sri Kali Charan has already submitted his property statement upto financial year 2011-12 which was seen by Hon'ble Mr. Justice Krishna Murari, the then Administrative Judge, Moradabad Judgeship on 22.07.2013 at flag 'Z' and the said statement is at flag 'M'.
