May kindly see the letter, placed below at flag 'A', received from Sri Kali Charan-II, Additional District & Sessions Judge, Deoria regarding submission of the statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2014-15, the income from salary is Rs.16,63,511/- (including encahment of Rs.88,225/- and D.A. Arrear of Rs.21,590/-) and income from agriculture is Rs.70,000/-. Thus, the total income is Rs.17,33,511/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.1,94,183/- against GPF, Rs.2,66,476/- against Income Tax, Rs.26,524/- against premium of LIC policies, Rs.60,000/- against Mutual fund and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.1,31,841/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.7,83,824/-. Thus, a sum of Rs.9,49,687/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(2) In the financial year 2015-16, the income from salary is Rs.17,00,200/- (including D.A. Arrear of Rs.18,920/-) and income from agriculture is Rs.90,000/-. Thus, the total income is Rs.17,90,200/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.2,38,510/- against GPF, Rs.2,54,920/- against Income Tax, Rs.26,524/- against premium of LIC policies, Rs.60,000/- against Mutual fund and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.1,64,608/- this financial year from previous year's balance. As such, total

deductions/ repayment/ savings/ investment is Rs.8,49,362/-. Thus, a sum of Rs.9,40,838/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

In this connection it is submitted that Sri Kali Charan-II has already submitted his property statement upto the financial year 2013-14 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then Administrative Judge, Moradabad on 04.08.2015 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 up to March 2017. He has submitted the movable and immovable property statement for the financial year 2014-15 & 2015-16 vide his letter dated 22.04.2017(at flag 'A'). As such, there is some delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, the property statements for the financial years 2014-15 & 2015-16 alongwith letter dated 22.04.2017 (at flag 'A') of Sri Kali Charan-II, Additional District & Sessions Judge, Deoria be laid before Hon'ble Mr. Justice A.R.Masoodi, Administrative Judge, Deoria judgeship for His Lordship's kind perusal and orders?
