If approved by the Learned Registrar General the medical reimbursement claims, amounting to Rs.51,887.00 of Sri Kali Charan Additional District & Sessions Judge (Ex-Cadre), Mirzapur, may be returned to the District Judge, Mirzapur with the request to take necessary action at his end under the provisions contained in Government Order no.2275/V-6-11-1082-87, dated 20.09.2011 as the claim is less than Rs.1,00,000.00?
