May kindly see the letter placed below at flag 'A', received from Sri Kali Charan, A.D.J., F.T.C., Bahraich regarding grant of permission to purchase an old Maruti Wagon R car.

In this case, the applicable Rule-24 (2) of U.P. Government Servant's conduct (Amendment) Rules, 1998 is as follows: -

"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

Therefore, if approved by Hon'ble Mr. Justice V.M. Sahai, Sri Kali Charan, A.D.J., F.T.C., Bahraich may be accorded permission to purchase second hand Maruti Wagon R car, bearing registration No. UP-25-W-6814, model-2006, from Sri. Gurdeep Singh, S/o Sri. Atar Singh, R/o A-1, Madhaw Badi, Near Ramayan Mandir, Bareilly for a sum of Rs.2,70,000/-, subject to the condition that he may furnish the papers relating to the transaction immediately on completion of the transaction?
