May kindly see the letter, placed below at flag 'A', received from Sri Harkesh Kumar, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property of the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2012-13 the income from Gross salary is Rs.13,05,986/- and from this amount, Rs.1,53,872/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,25,200/- against Income Tax, Rs.2842/- against LIC, and Rs.3,82,375/- against purchase of car, Rs.16,251/- against car loan and Rs.1,46,609/-(including interest) deposited in his PPF account in this year. As such, total deductions /repayment /savings/ investment is Rs.8,31,949/-. The balance of his saving bank account (s) is reduced to Rs.7,03,112/- from its previous year's balance. Thus, a sum of Rs.11,77,149/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2012-13.

(2) In the financial year 2013-14 the income from Gross salary is Rs.14,09,320/- and from this amount, Rs.2,17,125/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,94,900/- against Income Tax, Rs.2842/- against LIC, Rs.1,95,012/- against car loan and Rs.1,62,616/-(including interest) deposited in his PPF account in this year. The balance of his savings bank account (s) enhanced for Rs.2,713/- (including interest from its previous year's balance). As such, total deductions /repayment /savings/ investment is Rs.7,80,008/-. Thus, a sum of Rs.06,29,312/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Harkesh Kumar, has already submitted his property statement for the financial year 2011-12 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Devi Prasad Singh the then Administrative Judge, Ghaziabad at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through letter dated 21-08-2014 and as such, there is no delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2012-13 & 2013-14 alongwith letters dated 21-08-2014 (flagged 'A') of Sri Harkesh Kumar Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
