May kindly see the letters dated 14.9.16 and 29.11.16 (flagged 'A' and 'A-1') by which Sri Harkesh Kumar, Additional District and Sessions Judge(FTC), Lalitpur has submitted his movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2014-15, of Sri Harkesh Kumar's total income from Salary is Rs.17,02,984/- from this amount Rs.207606/- deducted against GPF, Rs.4800/- against GIS, Rs.2,26,493/- against Income Tax, Rs.52,842/- against Insurances, Rs.1,00,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.2,54,250/- this year. As such, total deductions/repayment/Savings/investment is Rs.8,45,991/-. Thus a sum of Rs.8,56,993/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2014-15.

(2) In the financial year 2015-16, of Sri Harkesh Kumar's total income from Salary is Rs.17,41,231/- from this amount Rs.2,06,130/- deducted against GPF, Rs.4800/- against GIS, Rs.2,69,126/- against Income Tax, Rs.52,842/- against Insurances, Rs.1,00,000/- against PPF. As such, total deductions/ repayment/ Savings/ investment is Rs.6,32,898/-. The balance of his Saving Bank Account(s) decreased for Rs.2,50,024/- this year. Thus a sum of Rs.13,58,357/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer firstly vide his letter dated 14.9.16 (flagged 'A') which was due to be submitted in third financial years 2016-17. As such there is no delay in submitting the Property statement from the part of officer.

In this connection it is submitted last time Sri Harkesh Kumar had already submitted his property statement upto financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Arun Tandon, the then Administrative Judge, Ghaziabad Judgeship on 18.10.14, which is at flag 'Z' and the said statement at flag 'M'.
