Sir,

I am directed to refer to the Court's Circular letter No. 63/IV-h-16/Admin. (A)/Dated 10.12.98, and to say that as per report of record room of Sri Avinash Saxena, Additional Civil Judge, (Junior Division), Ghaziabad it has been found that he has not submitted his property statements for the calendar year 2000 to the Court as desired by the Court, vide aforesaid Court Circular Letter dated 10.12.1998.
