

May kindly see the letters at flag A' & B' from Sri Lallu Singh, Civil Judge (Sr. Div.), Haweli, Faizabad.

Sri Lallu Singh has stated in his letter at flag A' that he wants to go to Kailash Mansarovar with his mother for pilgrimage. As he wants to apply for a passport, he needs a 'No-objection Certificate' from the Hon'ble Court. He has requested the Court to issue him an N.O.C. for obtaining a passport.

Thereupon he was asked through the Court's letter dated 4.6.99 at flag C' to furnish following information to the Court:-

- (1) Whether there is any possibility of arising disharmony between the Govt. of India and the Govt. of U.P. due to his visit to a foreign country.
- (2) Whether he had visited any foreign country earlier and if so, mention when and for what purpose he had visited the country.
- (3) Whether issue of N.O.C. for obtaining a passport was ever refused to him.

In reply of the aforesaid letter Sri Lallu Singh has stated in his letter (at flag B') that:-

- (1) There is no possibility of arising disharmony between the Govt. of India and the Govt. of U.P. due to his foreign visit.
- (2) He has not <sup>yet</sup> visited any foreign country.
- (3) He has never applied for issue of N.O.C. for obtaining a passport earlier.

In this connection it is submitted that as per reports from vigilance and confidential sections, no vigilance / departmental enquiry is pending against Sri Singh. As such in terms of G.O. NO-1/3/98- on 5.7.99/1999 14.6.99 (a photocopy at flag D) there seems no objection in issue of N.O.C. for obtaining a passport in favour of Sri Singh.

If approved by Hon'ble Mr. Justice S.K. Phaujdar, J. - Faizabad Judgeship, the N.O.C. at flag 'X' may be issued in favour of Sri Singh for obtaining an Indian passport as requested by him, provided that before proceeding abroad he will obtain permission of the court for the same?
