May kindly see the letter dated 21.4.14(flag 'A') received from Sri Lallu Singh, Additional District and Sessions Judge, Lucknow regarding submission of statements of movable and immovable properties acquired/held by him or by any member of his family for the financial years 2012-13 and 2013-14 in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by his are given below:-

(1) In the financial year, 2012-13, Sri Singh's income from salary and others sources is Rs.15,72,167/- from this amount, he has paid Rs.1,21,753/- against GPF, Rs.4800/- against GIS, Rs.1,00,000/- against PPF, Rs.1,71,900/- against Income Tax and Rs.1,20,000/- against Housing loan installment. The balance of his Saving Bank Account(s) neither enhanced nor decreased in this financial year. As such, total deductions /Savings /investment is Rs.5,18,453/-. Thus a sum of Rs.10,53,714/- was therefore available with him to meet out the household expenditure of his family consisting of four members.

(1) In the financial year, 2013-14, Sri Singh's income from salary and others sources is Rs. <sup>17,30,507</sup> ~~15,90,467~~ from this amount, he has paid Rs.1,10,556/- against GPF, Rs.4800/- against GIS, Rs.1,33,000/- against Income Tax and Rs.1,20,000/- against Housing loan installment. The balance of his Saving Bank Account(s) enhanced for Rs.1,03,203/- this financial year. As such, total deductions /Savings /investment is Rs.3,51,859/-. Thus a sum of Rs.13,78,648/- was therefore available with him to meet out the household expenditure of his family consisting of four members.

In this connection, it is submitted that Sri Singh's has already submitted his property statement upto financial year 2011-12 which has already been seen by Hon'ble Mr. Justice Vineet Saran, Administrative Judge, Lucknow Judgeship on 15.10.12 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his

letter dated 21.4.14 (flag 'A') which was due to be submitted in third financial year 2014-15 i.e. on or before 31.3.2015 . As such there is no delay in submission of the aforesaid Property statement from the part of the officer.

May, if approved, the statements of movable and immovable property for 2012-13 and 2013-14 of Sri Lallu Singh, Additional District and Sessions Judge, Lucknow may kindly be laid before Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders ?
