May kindly see the letter dated 26.7.16, placed below (at flag 'A') received from Sri Lallu Singh, Additional District and Sessions Judge, Auraiya by which he has submitted his revised movable property statement for the financial years 2014-15 and 2015-16.

Earlier Sri Singh has submitted his aforesaid Statements vide his letter dated 18.4.16(flag 'B') in which some informations/papers like movable property statement was not on proper and complete proforma, balance of S.B.A/c and PPF A/c were not at the end of the financial years, details of FDR and SBI Life Insurance policy has not mentioned by him, and he has not mentioned the repayment/source /details of house loan of Rs.20,25,000/- taken by him, hence a Court's letter dated 7.6.16(flag 'C') has been sent to the officer in this regard. In reply of aforesaid Court's letter, officer has submitted his revised property statements for the aforesaid periods vide his letter dated 15.6.2016(flag 'D') in which he has not mentioned required information which was asked vide Court's letter dated 7.6.16. Again a Court's letter 1.7.2016(flag 'E') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted his revised property statements for the aforesaid period after mentioning the required informations and supporting papers

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(i) In the financial year 2014-15, Sri Singh's, total income from Salary and other sources is Rs.19,36,647/- (Rs.16,38,841/- from Salary, Rs.45,000/- from Agriculture, 17,806/- from Petrol allowance, Rs.26,000/- from interest of S.B.A/c, Rs.1,25,000/- from interest of FDR), from this amount, he has paid Rs.1,01,883/- against GPF, Rs.4800/- against GIS, Rs.1,00,000/- against PPF, Rs.1,21,900/- against Income Tax. The officer has deposited Rs.1,52,000/- in his Saving Bank Account(s) this financial year. As such, total deductions /Savings/investment is Rs.4,80,583/-. Thus a sum of Rs.14,56,064/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(ii) In the financial year 2015-16, Sri Singh's, total income from Salary and other sources is Rs.23,54,643/-,(Rs.17,07,383/- from Salary,

Rs.30,000/- fro Agriculture, Rs.52,442/- from Petrol allowance, Rs.53,695 from interest of S.B.A/c, Rs.1,26,100/- from interest of FDR, Rs.138023/- from maturity of SBI Life Insurance, Rs.15,000/- LIC Money back policy, Rs.1,42,000/- from Maturity of LIC and Rs.6259/- paper/Magazine ), from this amount, he has paid Rs.1,10,409/- against GPF, Rs.4800/- against GIS, Rs.1,50,000/- against PPF, Rs.2,13,703/- against Income Tax. The officer has deposited Rs.9,32,720/- in his Saving Bank Account(s) this financial year. As such, total deductions /Savings/investment is Rs.14,11,632/-. Thus a sum of Rs.9,43,011/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

In this connection it is submitted that Sri Singh has already been submitted his property statement upto the financial year 2013-14 which has been seen by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship, which is at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Lallu Singh, Additional District and Sessions Judge, Auraiya be laid before Hon'ble Mr. Justice Mohd. Tahir, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders ?

May kindly see the letter, placed below at **flag 'A'**, received from Sri Lallu Singh, Additional District & Sessions Judge, Auraiya regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 and 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17, income from salary is Rs.18,49,445/-, income from Agriculture is Rs.37,000/-, interest on SB a/c is Rs.1,15,204/-, income from rent is Rs.88,000/- and matured amount of Insurance policy is Rs.52,450/-. Thus, the total amount is Rs.21,42,099/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.84,000/- against GPF, Rs.4,21,920/- against Income Tax and Rs.1,50,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.6,62,562/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.13,23,282/-. Thus, a sum of Rs.8,18,817/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

(2) In the financial year ~~2017-18~~, income from salary is Rs.20,82,749/-, income from Agriculture is Rs.45,000/-, interest on SB a/c is Rs.1,19,426/- and income from rent is Rs.99,000/-. Thus, the total amount is Rs.23,46,175/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.84,000/- against GPF, Rs.5,15,847/- against Income Tax and Rs.1,50,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.4,24,520/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.11,79,167/-. Thus, a sum of Rs.11,67,008/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

In this connection it is submitted that Sri Lallu Singh has already submitted his property statement upto the financial year 2015-16 (statement is at **flag 'M'**) which had



already been seen by Hon'ble Mr. Justice Mohd. Tahir, the then Administrative Judge, Auraiya at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted the movable and immovable property statement for the financial year 2016-17 & 2017-18 vide his letter dated 11.04.2018(at flag 'A'). As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2016-17 and 2017-18 alongwith letter dated 11.04.2018 (at flag 'A') of Sri Lallu Singh, Additional District & Sessions Judge, Auraiya be laid before Hon'ble Mr. Justice Ifaqat Ali Khan, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
