AN AGREEMENT made 18th day of 2002 ~~one thousand nine~~
~~hundred and~~ corresponding to Saka Samvat
 BETWEEN Sri Lalle Singh son of Sri Raksh. Pal Singh
 resident of T/12/3, Officer's colony (designation) Civil Judge (S.D.) (hereinafter called
 'the Borrower' which expression shall include his legal representative and
 assignees of the one part and THE GOVERNOR OF UTTAR PRA DESH
 (hereinafter called 'the Governor) of the other part WHEREAS the
 Borrower has under the provisions of the Account Rules of the Government
 of Uttar Pradesh (hereinafter referred to as 'the said Rules' which expression
 shall include any amendments thereof for the time being in force) applied
 to the Governor for a loan of Rs. 80,000 (Rupees eighty thousand) only

 from the date of these presents to expend the full amount of the said loan

 become due and payable AND the Borrower doth hereby agree and declare
 that the Governor may on the certificate of the Secretary to the State
 Government in the Administrative Department, which shall be final,
 conclusive and binding on the Borrower, recover all dues hereunder as
 arrears of land revenue.
