- 5(5) *Any Officer, whose assistance has been sought under sub-section (4), shall render all assistance to the Central Public Information Officer or State Public Information Officer, as the case may be, seeking his or her assistance and for the purposes of any contravention of the provisions of this Act, such other officer shall be treated as a Central Public Information Officer or State Public Information Officer, as the case may be.*

In the view of the above, kindly direct the official/Officer concerned to provide the desired information as sought by the applicant in the said RTI application at the earliest, but not later than 03 days, so that the same may be provided to the applicant within the specified time of 30 days with the permission of Hon'ble the Chief Justice.

The applicant has deposited the requisite fee as per the provisions of Rule 3 and 4 (amended) of Allahabad High Court(Right to Information) Rules, 2006.
