

May kindly see the letter dated 1.9.2000 (flagged 'A') of Sri Laloo Singh, Judicial Magistrate, Faizabad duly forwarded by the District Judge, Faizabad regarding removal of anomaly in his pay with that of his junior Sri Hasee Nath Pandey.

In the aforesaid letter Sri Laloo Singh has stated that he took over charge in U.P. Nyayik Seva on 4.9.93. In accordance with the provisions of g.o. issued in respect of recommendation of Jtu pay commission his basic pay has been fixed @ Rs. 8,000/- P.M. w.e.f. 1.1.1996 and his increment month is September. (Copy of pay fixation order is at flag 'B').

He has also stated that Sri Hasee Nath Pandey who was posted at Patappash in the year 1998, was also appointed in U.P. Nyayik Seva on 15.5.94 and his basic pay was also revised @ Rs. 8,000/- P.M. w.e.f. 1.1.1996 in accordance with the provisions of g.o. issued in respect of recommendations of Jtu pay commission and his increment month is May. (Copy of pay fix. order is at flag 'D') As such Sri Hasee Nath Pandey being junior to him is getting increment before 5 months to him, every year. In accordance with the rule senior government servant of an identical post shall not get less pay than his junior government servant.

Informally he came to know that, to remove such anomaly provisions have been made in the present g.o..

He has requested that ^{this} anomaly in his basic pay may kindly be removed and his ^{month of} annual increment may kindly be changed from the month of ~~May~~ September to May every year.

In this connection it may be submitted that in accordance with the provisions made in Para (2) of clause VI of G.O. No. Pa. Ma. Ni. 35/X-21(M)/97 dated 31.12.97 (Photocopy at flag 'C'):-

"Besides it such matters which are not covered under previous para, where pay of a junior government servant of the same category, whose basic salary in present pay scale is less than that of his senior government servant and has been fixed equal to that of his senior government servant on 1.1.1996 in revised pay scale, and the date of increment of a junior government servant is prior to senior government servant than next increment shall be given to senior government servant from the date of increment of his junior government servant."

Moreover, the work pertaining to fixation of pay etc. of the judicial officers of U.P. Nyayek Saka and U.P. Higher Judicial Service are being dealt with by the Joint Director (Treasuries) camp office, New Treasury Building, 1st floor, Kutchery Road, Anahabad.

Therefore, if approved by Hon'ble Mr. Justice S.N. Agarwal a copy of letter dated 1.9.2000 (flagged 'A') of Sri Lalloo Singh, Judicial Magistrate, Faizabad along with its enclosures may be sent to the Joint Director (Treasuries) camp office, New Treasury Building, 1st floor, Kutchery Road, Anahabad for taking necessary action in the matter in accordance with the provisions of Para 2 of clause VI of G.O. No.
