May kindly see the letter dated 12.09.2012 of Sri Lallu Singh, Additional District & Sessions Judge, Lucknow duly forwarded by District & Sessions Judge, Lucknow regarding grant of personal pay under voluntary family planning programme, in terms of G.O. Pa. Ka. 4601/16-11-79-9/155/79, dated 23.02.1980 placed below at Flag 'A'.

According to papers received from Sri Lallu Singh through application dated 12.09.2012 and letter dated 08.11.2011 papers available on his instant personal/ Misc. file details of the claim are as under:

1. His date of birth is 20.04.1964.
2. His present age is 48 years 5 months as per his declaration but presently his age is more than 49 years.
3. He joined the service on 04.09.1993.
4. He has two children vide declaration at Flag 'B'.
5. The date of birth of his youngest child is 26.01.1999. He has submitted original certificate for birth proof issued by City Montessori Inter College, Lucknow which are at Flag 'C'.
6. He has not got the personal Pay under voluntary family planning programme vide declaration at Flag 'D'.
7. His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at flag 'B'.
8. As reported by Section Officer (Confidential-A) section at flag 'E' No Departmental enquiry is pending against Sri Lallu Singh, aforesaid.

“Regarding punishment, it is submitted that the reply/explanation dated 10.06.2009 submitted by Sri Lallu Singh, the then Judicial Magistrate, Faizabad to show cause notice dated 28.05.2009 issued in view of the Administrative Committee resolution dated 25.05.2009 in the matter of enquiry report dated 02.05.2009 in V.B. Enquiry no. 19/2001 submitted by Sri V.P. Pathak, the then Special Officer (Vigilance), High Court, Allahabad was considered in the Hon'ble A.C. meeting held on 29.07.2009 & it was resolved to inflict the punishment of Censure to the Officer concerned.

As per the restriction of G.O. No. Pa-Ka 4601/16-11-79-9/155/79 dated 23.02.1980, (at Flag 'G') the benefit of Personal Pay can not be sanctioned to a

Government employee against whom any departmental enquiry is pending or has been suspended in connection with such enquiry or has been punished by stoppage of increment.

Hence, according to aforesaid report of Section Officer(Confidential-A), Officer has inflicted by the punishment of censure. Neither any departmental enquiry is pending against Sri Lallu Singh, Additional District & Sessions Judge, Lucknow nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry.

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79 dated 26.05.1980 and G.O. Pa.Ka. 2667/16-11-80-9/155/79 dated 11.06.1980 required declaration have been furnished by Sri Lallu Singh and same are at Flag 'B'.

In this connection, it is submitted that Sri Lallu Singh, Additional District & Sessions Judge, Lucknow has fulfilled all the conditions as laid down in the aforesaid G.O.s for sanction of personal pay under voluntary family planning programme. Therefore he is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment with effect from 26.01.2009 when he completed 40 years of age and his child completed 10 years of age being his date of birth i.e., 26.01.1999.

If approve, The file may therefore kindly be laid before Hon'ble Mr. Justice S. K. Singh for his Lordship kind perusal and order to sanction personal pay under voluntary family programme equal to one increment w.e.f. 26.01.2009 to Sri Lallu Singh, Additional District & Sessions Judge, Lucknow and his Lordship may also be requested to sign draft sanction order placed below at the place cross marked with red pen.
