May kindly see the letter, placed below at flag '1', received from Sri Lallu Singh, Additional District & Sessions Judge, Lucknow, by which he has submitted supplementary details/ papers in connection with information about purchase of flat no. 9, Block 'C', Sector- Omicron-2, Greater Noida measuring 120 sq. meters, purchased on 31.05.2010, in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of above mentioned flat for Rs. 22,82,500/- in total through his letter dated 28.10.2010 (flag 'A'). The matter was submitted before Hon'ble Mr. Justice Sanjay Misra, vide office note dated 09.04.2012 (flagged '2'). On the forwarding note dated 18.04.2012 of Ld. Registrar (Budget), His Lordship had been pleased to order on 23.05.2012 (flag '3' ante), reproduced as below:-

"The officer has purchased the flat on 31.05.2010 and attached copy of bank passbook only for a period up to 05.02.2007, therefore, he be required to furnish attested copy of bank passbook for the period up to the date of transaction.

He may also give source of amount credited to his account, in case any such credit exceeds the amount of his one month's salary."

The order was communicated vide Court's letter dated 02.06.2012 (flag '4').

In reply of the Court's letter dated 02.06.2012, Sri Lallu Singh, vide his letter dated 23.08. 2012 at flag '1', has submitted copy of statement of his said bank account no. 10125951202, SBI, from Feb. 2005 till the date of transaction i.e. May 2010 duly attested by the bank (flag '5'), showing payment details and has also stated that in the same account only Rs. 2,00,000/- credited on 26.07.2008 by withdrawal of the same from PPF account, which exceeds to his one month's salary. Apart from the same entry, there is no such credit in the same, which exceeds to his one month's salary.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal & acceptance of information about purchase of the flat by the officer?
