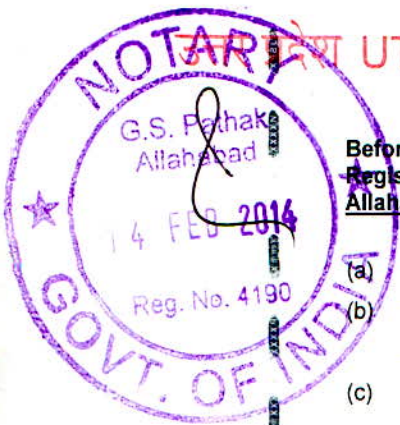
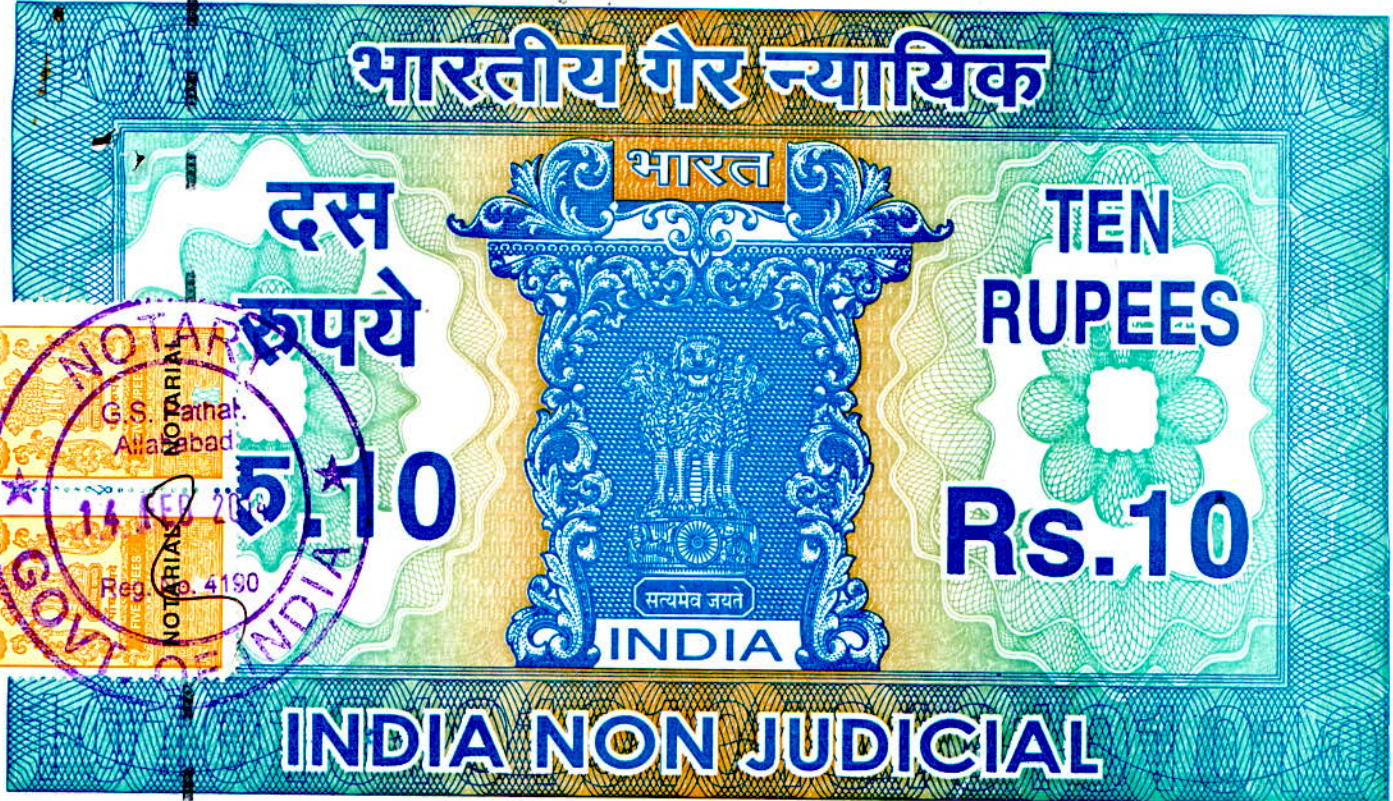

- (f) That proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India;
- (g) That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
- (h) That the applicant has not been repatriated.
