May kindly see the letter dated 9.4.14 (flag 'A') received from Sri Alok Kumar Parashar, Additional Principal Judge, Family Court, Allahabad regarding submission of statements of movable and immovable properties acquired/held by him or by any member of his family for the financial years 2010-11 and 2011-12 in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11 and 2011-12 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial years 2010-11, Sri Parashar's total income from Salary and other Sources is Rs.16,44,713/- from this amount he has paid Rs.2,17,731/- against GPF, Rs.1440/- against GIS, Rs.1,92,978/- against Income Tax, Rs.5000/- against PPF, Rs.20,000/- Tax Saving Bond, Rs.15,299/- against LIC installments, Rs.6,89,197/- against Home loan repayment. The balance of his Saving Bank Account(s) enhanced for Rs.1,45,410/- this year. As such, total deductions /Savings/investment is Rs.12,87,055/- . Thus a sum of Rs.3,57,658/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.

(2) In the financial years 2011-12, Sri Parashar's total income from Salary and other Sources is Rs.20,23,186/- from this amount he has paid Rs.3,00,031/- against GPF, Rs.3400/- against GIS, Rs.3,90,581/- against Income Tax, Rs.70,000/- against PPF, Rs.20,000/- Tax Saving Bond, Rs.15,299/- against LIC installments, Rs.25,000/- against ICICI Health Saving Bond. The balance of his Saving Bank Account(s) enhanced for Rs.4,68,467/- this year. As such, total deductions /Savings/investment is Rs.12,92,778/- . Thus a sum of Rs.7,30,408/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.

In this connection, it is submitted that Sri Parashar's has already submitted his property statement upto financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Prakash Krishna, Administrative Judge, Allahabad Judgeship on 21.12.10 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2010-11 and 2011-12 has been submitted by the officer vide his letter dated 9.4.14(flag 'A') which was due to be submitted in third financial year 2012-13 i.e. on or before 31.3.13 . As such there is delay in submission of the

aforesaid Property statement from the part of the officer.

May, if approved, the statements of movable and immovable property for 2010-11 and 2011-12 of Sri Alok Kumar Parashar, Additional Principal Judge, Family Court, Allahabad may kindly be laid before Hon'ble Mr. Justice Dilip Gupta, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders ?
