In view of the Court's Circular letter no. 63/IV-h-16/
Admn. (A) dated 10-12-98, Sri Sunil Kumar Misra, ^{the then} Additional
Civil Judge (Jr. Div.) Tilhar, Shahjahanpur, ^{now posted in Varanasi judiciary} has furnished
statement of his movable properties exceeding the value
of Rs. 10,000/- and immovable properties held / acquired
by him or by any members of his family in any earlier
years and during the calendar year 2001 on the Prescribed
Proforma to this Court's for kind perusal and information.
The statement of movable and immovable property are
placed below respectively.

On perusal of the property statement Sri Misra
was asked vide Court's letter No. 13705/IV-2670/
Admn. (A) dated 18.9.2002 at Flag 'C' to furnish
following information / papers to this Court as
under :

1. Details about deduction in G.P.F., G.I.S. Income Tax
House Rent, L.I.C., P.P.F. advance or loan, if any,
and other investment during the calendar year 2001.
2. Details of Savings Bank A/c No. 12943 and P.P.F.
A/c No. 213 and amount deposited during the year 2001
as well as balance amount in the aforesaid A/c as on
31.12.2001.
3. Property statement also for the year 2000 on the
prescribed proforma alongwith cause of delay for not
submitting the property statement in time to the Court."

In reply of the above Court's letter Sri Misra
has furnished information about his properties, as
required by the Court's letter, ^{dt 18.9.2002,} vide his letter dated
1.11.2002 at Flag 'D' and statement about movable and
immovable property also for the calendar year 2000 which

are at Flag 'X' & 'Y'. Contents of the letter are given below in his own language:

ससम्मान अवगत कराना है कि श्री कैलाश प्रसाद, उप निबन्धक, माननीय उच्च न्यायालय, इलाहाबाद ने अपने उपरोक्त विषयक पत्र के द्वारा मेरे वर्ष -2001 की सम्पत्ति सम्बन्धी भेजे गये विवरण पत्र के सम्बन्ध में जी०पी०एफ०, जी० आई०एस०, आयकर, एच० आर० ए०, बैंक ~~शुभ~~, एल० आई० सी० एवं पी०पी० एफ० आदि के बारे में स्पष्ट सूचना मांगी गयी है, तथा वर्ष-2000 का पुनः विवरण-पत्र भी मांगा है। इस सम्बन्ध में अपनी सम्पत्ति सम्बन्धी विवरण-पत्र में पूरे स्पष्ट सूचनायें भेज चुका हूँ, फिर भी उपरोक्त सम्बन्ध में उनके द्वारा मांगी गयी सूचनाओं को पुनः अंकित कर रहा हूँ।

वर्ष-2001 में मेरे वेतन को कुल आय लगभग 1,74,500/- रु है तथा कृषि भूमि से अर्जित आय मु० 25,000/- रु है और कुल आय मु० 1,99,500/- रु है तथा विनियोजन निम्न प्रकार है:-

कुल विनियोजित राशि: = मु० 59,348/- रु ।

इसके अतिरिक्त मेरे बचत बैंक खाता सं०-12943 में दि० 31.12.2000 को कुल मु० 17,482/- रु जमा थे और वर्ष-2001 का विवरण-पत्र भेजने की तिथि दि०: 19-02-2002 को मु० 23,000/- रु थे। जहाँ तक इस खाते में वर्ष भर में जमा की गयी धनराशि का प्रश्न है, इस सम्बन्ध में यह स्पष्ट किया जाता है कि वेतन से प्राप्त सम्पूर्ण धनराशि इसी खाते में जमा होती है जो वर्ष-2001 में सभी कटौतियों के बाद लगभग मु० 1.50 लाख रु थे और विनियोजित होने वाले व घर के अन्य वर्षों से सम्बन्धित धनराशियाँ आदि इसी खाते से आहरित होती हैं।

इसके अलावा उपरोक्त पत्र के माध्यम से बैंक लोन की सूचना भी मांगी गयी है। इस सम्बन्ध में यह स्पष्ट किया जाना है कि मैंने अपने भवन निर्माण हेतु बैंक आफ इण्डिया, शाखा-मोठा महासिंह, हरदोई से कुल मु० 3,00 लाख रुपये का ऋण मांगा था, जिसमें माह सितम्बर-2001 में मु० 2.00 लाख रुपये का ऋण स्विकृत हुआ था, जिसकी
