May kindly see the letter dated 8.1.15 (at flag 'A') of Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Azamgarh regarding clarification of submission of movable and immovable property statements for the financial years 2010-11 and 2011-12.

Earlier Sri Tgagi has submitted his property statements for the financial years 2012-13 and 2013-14 vide his letter dated 1.7.2014 (flag 'B') but he had not submitted his property statements for the financial years 2010-11 and 2011-12, hence a Court's letter dated 20.8.14(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer has submitted his property statements for the financial years 2010-11 and 2011-12 after mentioning that he has already submitted his aforesaid statements vide letter dated 13.4.2012 through District Judge, Jalaun at Orai while posting in Jalaun at Orai Judgeship and now he is again submitting the same vide his letter dated 3.9.14(flag 'D'). But as per report dated 25.9.14(flag 'D') of Record Room i.e. , (Admin.'H') Section, that the letter dated 13.4.2012 has not been received as yet in this regard. Then a Court's letter dated 18.10.2014('E') was sent to the District Judge, Jalaun at Orai to intimate as to whether Sri Brijendra Kumar Tyagi the then Additional District Judge, Jalaun at Orai now posted in Azamgarh Judgeship had submitted the said Property statements in his office or not. In reply of aforesaid Court's letter, District Judge, Jalaun at Orai vide his letter dated 7.11.2014(flag 'F') has inform this Court that as per office report Sri Brijendra Kumar Tyagi the then Additional District Judge, Jalaun at Orai has not submitted Property statements for the financial eyar 2010-11 and 2011-12 on dated 13.04.12 in this Judgeship . Therefore a Court letter dated 28.11.2014 ('G') has been sent to the officer to clarify about the aforesaid property statement to the Court at the earliest.

In reply Officer Officer through his letter dated 8.1.15(flag 'A') has stated that while posted as Additional District Judge, Jalaun at Orai property statements for the financial years 2010-11 and 2011-12 were submitted in the office of the District Judge Jalaun at Orai on 13.4.12 but it is not in his memory as to whether receipt of the aforesaid letter was obtained or not from the office of the District Judge, Jalaun at Orai because he was transferred to Aligarh Judgeship during that period. As such he has mentioned in letter dated 3.9.14 that while posted as Additional District Judge, Jalaun at Orai he has furnished the property statements for the financial years 2010-11 and 2011-12 through letter dated 13.4.12 to the High Court of Judicature at Allahabad and he has regretted for delay and requested for acceptance of the said Property statements for the financial eyars 2010-11 & 2011-12.

In this connection, it is submitted that as per statement of movable

and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial years 2010-11, Sri Tyagi gross income from salary is Rs.13,47,145/- from this amount, he has paid Rs.2,56,760/- against GPF, Rs.1440/- against GIS, Rs.70,000/- against PPF, Rs.1,83,862/- against Income Tax, Rs.75,046/- against Insurance. The balance of his Saving Bank Account(s) enhanced for Rs.61,390/- this year. As such, total deductions /Savings/investment is Rs.6,48,498/-. Thus a sum of Rs.6,98,647/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2010-11.

(2) In the statement of movable and immovable property for the financial years 2011-12, Sri Tyagi gross income from salary is Rs.17,74,653/- from this amount, he has paid Rs.2,52,722/- against GPF, Rs.3960/- against GIS, Rs.1,00,000/- against PPF, Rs.2,97,328/- against Income Tax, Rs.75,046/- against Insurance. The balance of his Saving Bank Account(s) enhanced for Rs.3,11,060/- this year. As such, total deductions /Savings/investment is Rs.11,20,116/-. Thus a sum of Rs.6,54,537/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2011-12.

(3) In the statement of movable and immovable property for the financial years 2012-13, Sri Tyagi gross income from salary and other Sources is Rs.14,33,889/- from this amount, he has paid Rs.1,17,437/- against GPF, Rs.4800/- against GIS, Rs.1,00,000/- against PPF, Rs.1,38,466/- against Income Tax, Rs.87,056/- against Insurance. As such, total deductions /Savings/investment is Rs.4,47,759/-. The balance of his Saving Bank Account(s) decreased for Rs.2,11,375/- this year Thus a sum of Rs.11,97,505/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2012-13.

(4) In the statement of movable and immovable property for the financial years 2013-14, Sri Tyagi gross income from salary and other Sources is Rs.13,91,396/- from this amount, he has paid Rs.1,14,100/- against GPF, Rs.4800/- against GIS, Rs.1,00,000/- against PPF, Rs.1,94,002/- against Income Tax, Rs.87,056/- against Insurance. The balance of his Saving Bank Account(s) enhanced for Rs.66,413/- this year. As such, total deductions /Savings/investment is Rs.5,66,371/-. Thus a sum of Rs.7,95,025/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2010-11, 2011-12 has been submitted by the officer vide letter dated

3.9.14(flag 'D') and property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 1.7.14 (flag 'B'). The property statement for the financial years 2010-11, 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13 and property statement for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the Property statement for the financial years 2010-11, 2011-12 from the part of the officer for which officer has regretted.

In this connection, it is submitted that Sri Tyagi has already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Jalaun at Orai dated 5.5.2011 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Azamgarh may kindly be laid before Hon'ble Mr. Justice Ran Vijai Singh, Administrative Judge, Azamgarh Judgship for His Lordship's kind perusal and orders ?
