May kindly see the letter dated 15.11.2016(flag 'A' )) by which Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Azamgarh by which he has submitted his property statements for the financial years 2014-15 and 2015-16.



In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2014-15, Sri Tyagi's in come from gross Salary and other sources is Rs.14,36,187/- (Rs.14,16,187/- from gross Salary and Rs.20,000/- from Agriculture income)-, he has paid Rs.97,916/- against GPF, Rs.4800/- against GIS, Rs.79,463/- against LIC, Rs.1,50,000/- against PPF, Rs.1,77,128/- against Income Tax, Rs.7593/- against SBI Life Insurance. The balance of his Saving Bank Account(s) enhanced for Rs.1,52,168/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.6,69,068/-. Thus a sum of Rs.7,67,119/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Tyagi's in come from gross Salary and other sources is Rs.15,92,296/ (Rs.15,72,961/- from gross Salary and Rs.20,000/- from Agriculture income)-, he has paid Rs.1,51,434/- against GPF, Rs.4800/- against GIS, Rs.79,463/- against LIC, Rs.1,50,000/- against PPF, Rs.1,76,758/- against Income Tax, Rs.7,593/- against SBI Life Insurance. As such, total deductions /Savings/investment is Rs.5,70,048/-. The balance of his Saving Bank Account(s) decreased for Rs.2,35,185/- this year against the balance of previous year . Thus a sum of Rs.12,57,433/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 15.11.2016 (flag 'A') which was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Tyagi has already submitted his property statement upto financial year 2013-14 which was seen by Hon'ble Mr. Justice Ran Vijai Singh, the then Administrative Judge, Azamgarh on 1.6.2016 at flag 'Z' and the said statement is at flag 'M'.
