May kindly see the letter dated 3.4.18 (at flag 'A') of Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Muzaffarnagar regarding submission of movable and immovable property statements for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial years 2016-17, Sri Tyagi gross income from salary and other Sources is Rs.19,94,334/- (Rs.19,69,334/- is his gross Salary and Rs.25,000/- from income of Agriculture) from this amount, he has paid Rs.1,50,395/- against GPF, Rs.4800/- against GIS, Rs.79,463/- against LIC, Rs.1,50,000/- against PPF, Rs.3,06,556/- against Income Tax. As such, total deductions /Savings/investment is Rs.6,91,214/-. The balance of his Saving Bank Account(s) decreased for Rs.1,18,192/- this year. Thus a sum of Rs.14,21,312/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2016-17.

(2) In the statement of movable and immovable property for the financial years 2017-18, Sri Tyagi gross income from salary and other Sources is Rs.20,07,711/- (Rs.19,83,811/- is his gross Salary and Rs.25,000/- from income of Agriculture) from this amount, he has paid Rs.1,79,640/- against GPF, Rs.4800/- against GIS, Rs.1,00,682/- against LIC, Rs.1,50,000/- against PPF, Rs.3,27,476/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.1,50,346/- this year. As such, total deductions /Savings/investment is Rs.9,12,944/-. Thus a sum of Rs.10,95,867/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2017-18.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide letter dated 3.4.18(flag 'A') was due to be submitted in the financial year 2018-19 i.e. on or before 31.3.19. As such there is no delay in submitting the aforesaid statements from the part of the officer.

In this connection, it is submitted that Sri Tyagi has already submitted his

property statement upto financial year 2015-16 which was seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Azamgarh dated 13.2.2017 at flag 'Z' and the said statement is at flag 'M'.
