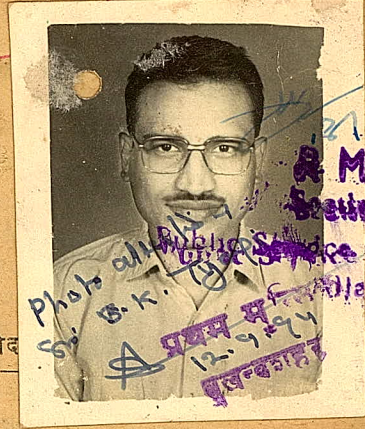
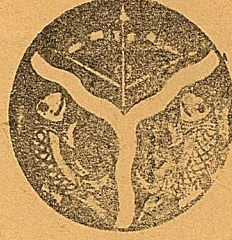

Maximum marks for each subject are 150 except in the case of Sciences without practical (subject Code-90) for which maximum marks are 105.

For a pass, a student must obtain at least Grade-E in Work Experience and 33% marks or Grade-E in five out of the remaining six compulsory subjects. Candidates who are exempted from Work Experience and or Physical & Health Education should, in order to pass the Examination, obtain at least 33% marks in each of the five subjects of external Examination.

Private, Adult school and the Patrachar Vidyalaya candidates are exempted from Physical and Health Education and Work Experience. They are required to appear in 5 subjects of external examination only, and passing in each of the five subjects is compulsory in order to pass the examination.

Grades in Work Experience and Physical & Health Education are based on internal assessment by the school. Ranges of marks in each Grade are: A 75% and above, B 60% to 74%, C 53% to 59%, D 45% to 52%, E 33% to 44%, F 15% to 32%, G 14% or less.

The candidates who have offered seven subjects, will get compartment if they fail in two subjects. Such candidates may appear in any one of the two subjects to clear the compartmental examination.

The candidates who have appeared in six or five subjects due to exemption (in one or both the subjects of internal assessment) will be placed in Compartment if they fail in only one subject.

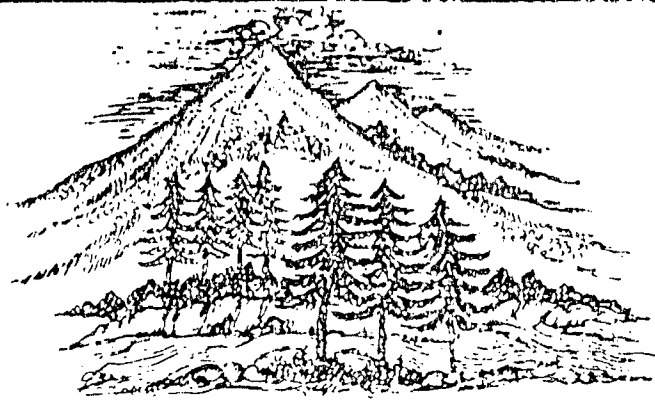

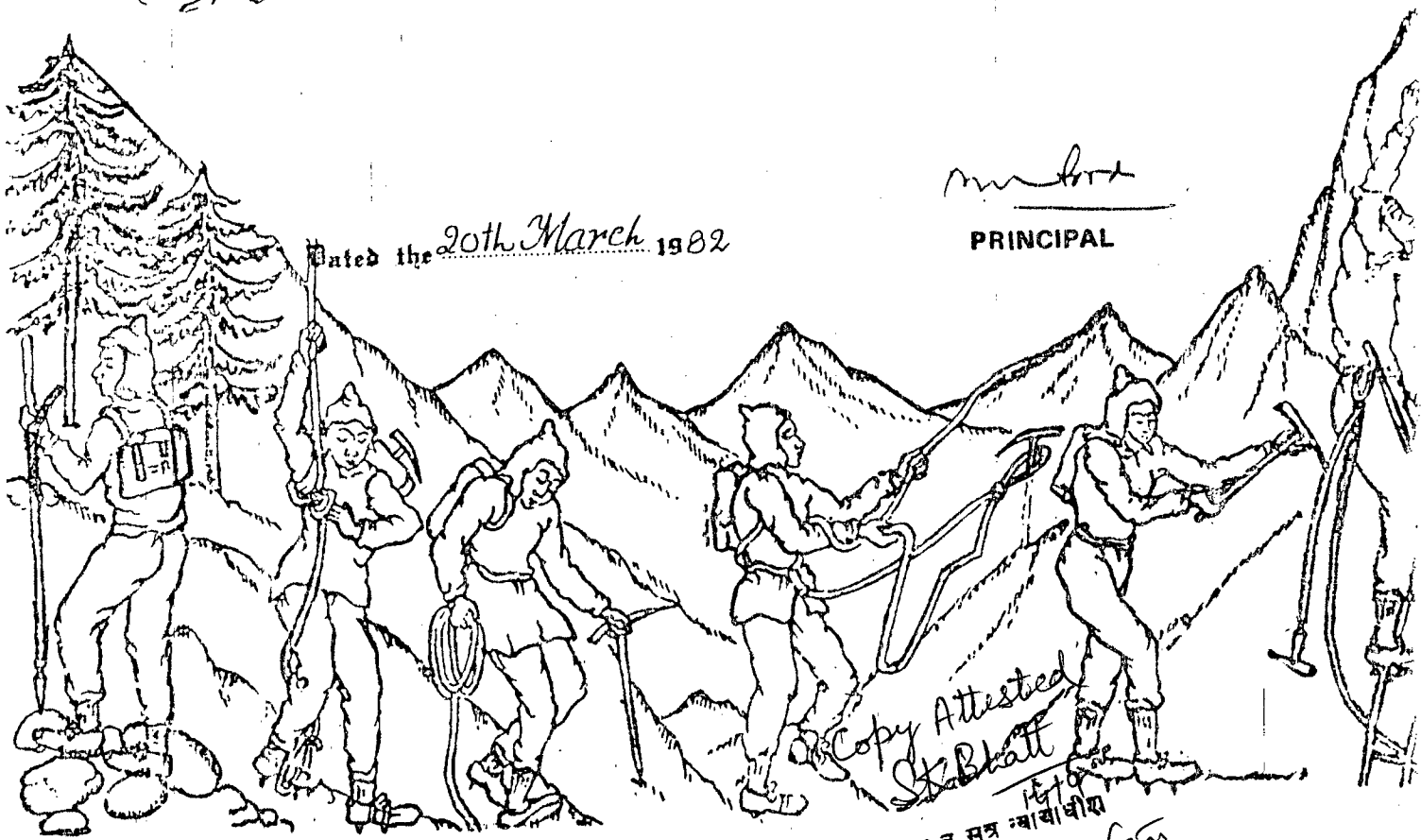

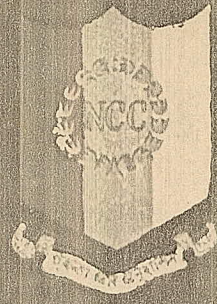

They should also be given training in Criminal work for three weeks. For two weeks they should sit with a Senior Magistrate trying cases and for one week with a Magistrate who commits cases to sessions. They should take notes of the evidence and write judgments which should be perused by the District Judge or by an Additional District & Sessions Judge nominated by the District Judge and comments should be noted thereon for their guidance.

All the notes prepared by them with comments should be forwarded to the Court.
