May kindly see the application dated 09.03.2011 of Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Jalaun at Orai through which he has submitted declaration (two duly filled up alongwith attested copies of certificate relating to age proof of his children, to this Court regarding grant of personal pay under voluntary family planning programme, in terms of G.O. Pa.Ka. 4601/16-11-79-9/155/79, dated 23.02.1980 placed below at Flag 'A'.

It may be recalled that earlier Sri Brijendra Kumar Tyagi, sent an application dated 15.03.2010 and applied for personal pay but he had submitted only one declaration with his application dated 15.03.2010 where as two declaration required under the rule. Therefore a Court's letter no.3947/IV-2699/ Admin A/ dated 03.03.2011 was sent to the District Judge, Jalaun at Orai alongwith format of declaration regarding grant of personal pay under voluntary family planning programme with a the request to ask Sri Brijendra Kumar Tyagi, to resubmit the same duly filled up in all respects to this Court for necessary action.

In a reply of Court's letter dated 03.03.2011 Sri Tyagi has submitted declaration alongwith attested copies of certificate of age proof of his child through his letter dated 09.03.2011, to this Court for necessary action.

According to papers received from Sri Brijendra Kumar Tyagi dated 09.03.2011, 15.03.2010 and papers available on his instant personal / Misc. file details of the claim are as under:-

1. His date of birth is 13.01.1965
2. His present age is 45 years 2 month 2 days as per declaration at flag 'C'.
3. He joined the service on 18.03.1996.
4. He has only one child vide declaration at flag 'C'.
5. The age of his child is 10 years and his date of birth is 09.03.1999 vide certificate issued by Principal, Sacred Heart Centenary Academy, Jalaun at Orai attested copy of certificate is at flag 'E'.
6. He has not got the personal Pay under voluntary family planning programme vide declaration at flag 'D'.
7. His wife is alive. She is not a government servant and she is not getting said benefit vide declaration at flag 'C'.
8. Neither any departmental enquiry is pending against Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Jalaun at Orai nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer (Confidential-A) section at flag 'F'.

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79, dated 26.05.1980 and G.O. Pa.Ka. 2667/16-11-80-9/155/79, dated 11.06.1980 required declaration have been furnished by Sri Brijendra Kumar Tyagi, and same are at flag 'C' and 'D'.

In this connection it is submitted that Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Jalaun at Orai has fulfilled all the conditions as laid down in the aforesaid G.Os for sanction of personal pay under voluntary family planning programme. Therefore he is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment with effect from

09.03.2009, When he has completed 40 years of age and his child completed 10 years of age being his date of birth 09.03.1999.

The file may therefore kindly be laid before Hon'ble Mr. Justice S.K.Singh for his Lordship kind perusal and order to sanction personal pay under voluntary family programme equal to one increment w.e.f. 09.03.2009 to Sri Brijendra Kumar Tyagi, Additional District and Sessions Judge, Jalaun at Orai and his Lordship may also be requested to sign draft sanction order placed below at the place cross marked with red.
