बचत बैंक खाता-नियमों से उद्धरण
पास-बुक

नियम 13 - पास-बुक में जमाकर्ता का खाता-क्रमांक, उसका नाम, व्यवसाय या पेशे का उल्लेख होगा। अगर आहरण चैक द्वारा न किया जाय तो हर आहरण के समय पास-बुक प्रस्तुत करना आवश्यक है। धन जमा करते समय पास-बुक प्रस्तुत करना अनिवार्य नहीं है, लेकिन बाद में उसमें प्रविष्टियाँ कराने के लिए यथासंभव शीघ्र ही बैंक को दे देना चाहिए। पास-बुक हर हालत में प्रति वर्ष अक्टूबर के प्रारंभ में ब्याज की प्रविष्टियाँ लिखने के लिए अवश्य प्रस्तुत की जानी चाहिए, जब पास-बुक पूरी हो जाने के बाद वापस मिले तो जमाकर्ता को चाहिए कि वह उसमें लिखी हुई सभी प्रविष्टियों की जाँच सतर्कतापूर्वक कर ले और अगर किसी भूल-चूक का पता लगे तो उसे बैंक को सूचित कर दे। पास-बुक की प्रविष्टियों की जाँच करने में और त्रुटियों/भूलों को बैंक को बताने में अगर जमाकर्ता चूक करे तो उसके परिणामस्वरूप खाताधारक को होनेवाली किसी भी प्रकार की क्षति के लिए बैंक कोई ज़िम्मेदारी नहीं स्वीकार करेगा। पास-बुक की उन प्रविष्टियों के लिए बैंक ज़िम्मेदार नहीं है, जो उसके किसी प्राधिकृत अधिकारी द्वारा सत्यापित न की गई हों।

नियम 14 - प्रत्येक जमा की गई/आहरित राशि की पास-बुक में प्रविष्टि करने के बाद खाताशेष राशि दर्शाई जायेगी और उस पर बैंक के किसी प्राधिकृत अधिकारी के हस्ताक्षर होंगे।

नियम 15 - जमाकर्ता यह सुनिश्चित करे कि वह समय-समय पर अपनी पास-बुक अद्यतन करने के लिए प्रस्तुत करता है, जमा या आहरण के

साथ या अलग से, जब भी पास-बुक बैंक को दी जाएगी उसमें प्रविष्टियाँ पूरी करने के बाद वह जमाकर्ता अथवा उसके प्राधिकृत प्रतिनिधि को वापस कर दी जायेगी।

नियम 16 - लेन-देन के तुरंत बाद ही पास-बुक में प्रविष्टियाँ कर दी जाती हैं, इसलिए खाताधारक या उसका प्राधिकृत प्रतिनिधि यथासंभव पास-बुक उसी दिन बैंक से वापस ले ले। पास-बुक बैंक में ही छोड़ने पर बैंक कागज के टोकन के रूप में एक रसीद देगा। इस टोकन को देकर सप्ताह के भीतर ही पास-बुक वापस ले लेनी चाहिए। खाताधारक यदि इस अवधि में पास-बुक वापस नहीं लेता तो उसे खाताधारक के खर्च पर उसके पास रजिस्टर्ड एंड्री डाक से भेज दिया जायेगा।

नियम 17 - जमाकर्ता को अपनी पास-बुक सुरक्षित स्थान पर रखनी चाहिए क्यों कि इस नियम के प्रति लापरवाही के कारण हुई किसी भी क्षति या गलत भुगतान के लिए बैंक जिम्मेदार नहीं होगा। खाताधारकों को पते में परिवर्तन की सूचना बैंक को शीघ्र ही दे देनी चाहिए, और साथ ही पास-बुक भेजकर उसमें यह परिवर्तन नोट करा लेना चाहिए।

पास-बुक खोने पर

नियम 18 - जमाकर्ता को दी गई प्रथम पास-बुक अथवा उसी क्रम में उसे दी गई दूसरी पास-बुक के लिये, जो निरस्त करने के बाद उसे वापस कर दी जाती है, कोई शुल्क नहीं लिया जायेगा। लेकिन पास-बुक खो जाने या नष्ट हो जाने पर (जमाकर्ता के नियंत्रण से परे किसी परिस्थिति में छोड़कर) पास-बुक की दूसरी प्रति के लिए जमाकर्ता से शुल्क स्वरूप दो रुपये लिये जायेंगे और यह पास-बुक अपेक्षित जाँच-पड़ताल के बाद ही दी जाएगी।

चैक के अलावा अन्य विधि से राशि आहरण करने की विधि

नियम 20 - जमाकर्ता जब भी राशि निकालना चाहे तो उसे स्वयं (बैंक द्वारा निर्दिष्ट) एक आहरण पर्ची यथाविधि भरकर अपनी पास-बुक के साथ देनी चाहिए।

नियम 21 - राशि आहरण (चैक के अलावा) के लिए यदि जमाकर्ता स्वयं न आ सके तो वह बचत खाते का आहरण आदेश (विद्यूवल फॉर्म) यथाविधि भरकर अपनी पास-बुक के साथ भेज सकता है।

नियम 22 - अनपढ़ जमाकर्ता यदि बैंक आने में असमर्थ हों तो वह आहरण आदेश या प्राधिकार पत्र पर अपने बायें हाथ के अंगूठे का निशान लगाकर, जो बैंक द्वारा मान्य दो व्यक्तियों या किसी मैजिस्ट्रेट द्वारा उसके कोर्ट की मुहर के साथ सत्यापित होना चाहिए, बैंक को भेज सकता है।

चैक द्वारा राशि आहरण की विधि

नियम 23 - चैकपरिचालित खातों से आहरण (नियम 36 के अध्याधीन), बैंक द्वारा प्रदत्त चैक फॉर्म पर अनुमत है। बैंक को अधिकार है कि वह इसके अलावा अन्य किसी भी चैक द्वारा आहरण न स्वीकार करे। जमाकर्ता को नई चैक-बुक सामान्यतया उसके उपयोग की चैक-बुक में लगाई गई बैंक की मांगपर्ची पर ही हस्ताक्षर कर आवेदन करने पर दी जाती है।

नियम 24 - यदि चैक में किसी प्रकार का परिवर्तन किया हो और इन परिवर्तनों को लेखीवाल (चैक आहरण करनेवाले) के हस्ताक्षरों से

प्रमाणित न किया गया तो बैंक ऐसे चेकों का भुगतान न करने के लिए स्वतंत्र है। बैंक इस प्रकार आहरित करना चाहिए कि जारी करने के पश्चात् उसमें किसी प्रकार का परिवर्तन न हो सके और उसका हस्ताक्षर बैंक को दिये गये नमूने के हस्ताक्षर के अनुरूप हो। बैंक-बुक को सदा सुरक्षित स्थान पर रखना आवश्यक है।

नियम 25 - बैंक, बैंक खोलने या चोरी हो जाने आदि के विषय में लेखीवाल के निर्देश नोट कर लेगा लेकिन इस प्रकार के चेकों का भुगतान नहीं होगा, ऐसी कोई गारंटी लेखीवाल को नहीं दे सकता।

नियम 31 - बचत खाता खोलने के लिए कम से कम रु. 20 की राशि स्वीकार की जाती है लेकिन उसके बाद रु. 1/- से कम राशि की जमा नहीं स्वीकार की जाती, जिन बचत खातों की खाताशेष राशि रु. 20 से कम रह जाये, बैंक स्वविकेकानुसार इस प्रकार के खातों को बंद कर सकता है। उन बचत खातों में, जिनमें बैंक द्वारा आहरण की सुविधा है, कम से कम रु. 100 की राशि शेष रहनी चाहिए।

नियम 33 - बचत खाताधारकों को छह माह में उनके खातों में 50 से अधिक बार नामों की अनुमति नहीं है। इसमें हर तरह के नाम जैसे बैंक, अंतरण, पत्र, स्थायी निर्देश या किसी भी अन्य विधि से नाम शामिल हैं। छ माही प्रारंभ हो चुकने के बाद खोले गये खातों के लिए अनुमत आहरणों की संख्या समानुपातिक आधार पर गिनी जायेगी। इसके लिये चेकों के मामलों में बैंक की तिथि के बजाय अदायगी की तिथि ही आहरण की तिथि मानी जायेगी।

नियम 34 - रु. 1/- से कम की राशि या रु. 1/- के गुणकों की राशि का न होने पर (सिवाय खाता बंद करने के अवसर को छोड़कर) आहरण

जमाकर्ता नहीं कर सकता। खाता बंद करते समय खाते में शेष सारी राशि, चाहे जितनी भी हो, निकाली जाती है। बैंक द्वारा आहरण के मामले में, राशि को एक रुपये का गुणक होना आवश्यक नहीं है। बैंक द्वारा रु. 3,000 से अधिक और रु. 5 से कम की राशि नहीं निकाली जानी चाहिए, जमाकर्ता यदि रु. 3,000 से अधिक की राशि निकालना चाहे तो उसे आहरण पर्ची का उपयोग करना चाहिए।

ब्याज

नियम 37 - बचत खातों में जमा राशि पर दिये जाने वाले वर्तमान ब्याजदर की बैंक से पुष्टि की जा सकती है। ब्याजदर भारतीय रिज़र्व बैंक द्वारा नियंत्रित होती है। इसमें सभी परिवर्तनों को समाचार पत्रों के माध्यम से सूचित कर दिया जाता है।

PASS - BOOK

Rule 13 - The pass-book will show the number of the depositor's account, his name, occupation or profession and address. The pass-book must be presented for all withdrawals other than by cheques. Deposits may be made without production of the pass-book, but the pass-book should be sent to the Bank for completion as soon as possible thereafter. In any case, the pass-book should be sent to the Bank early in October each year for recording the entry in respect of application of interest. When the pass-book is returned duly completed, the depositor should examine the entries carefully and draw the Bank's attention to any errors or omissions that might be discovered. The Bank will not accept any responsibility for any loss arising out of failure on the part of the account-holder to carry out examination of the entries in the pass-book and to point out to the Bank errors and/or omissions in the pass-book. The Bank will not be responsible for any entries in the pass-book not authenticated under the initials of its authorised official.

Rule 14 - Each amount deposited/withdrawn will be entered in the pass-book and a fresh balance struck under the initials of an authorised official of the Bank.

Rule 15 – Depositors should ensure that their pass-books are presented at intervals for updating. A pass-book whenever tendered either with a deposit or a withdrawal or separately will be made up and returned to the depositor or his authorised representative.

Rule 16 – Pass-books should, as far as possible, be collected from the Bank by the account-holders or their authorised representatives on the same day duly filled up and completed immediately after the transaction. If left overnight, the Bank will issue a receipt in the form of a paper token. The pass-book should be collected against this token within a week. If the account-holder fails to collect the pass-book within this period, the pass-book will be sent to his address by registered A.D. post at his cost.

Rule 17 – Depositors are advised to keep their pass-books in a place of safety, as the Bank will not be responsible for any loss or incorrect payment attributable to the neglect of this rule. Any change in the address of the depositor should be immediately intimated to the Bank and the pass-book forwarded for noting the change.

LOSS OF PASS-BOOK

Rule 18 – No charge will be made for the pass-book first supplied to a depositor or for any pass-book issued to him in continuation of the original pass-book

which will be cancelled and returned to him. But if a pass-book is lost or spoiled (except in circumstances over which the depositor had no control) the depositor will be charged two rupees for a duplicate pass-book which will only be issued after due enquiry.

MODE OF WITHDRAWING MONEY OTHER THAN BY CHEQUE

Rule 20 – When a depositor wishes to withdraw money (other than by cheque) he should present his pass-book personally along with a withdrawal order form (prescribed by the Bank) duly completed.

Rule 21 – When a depositor is unable to attend personally for withdrawing money (other than by cheque), he may send his pass-book along with savings bank withdrawal order form duly completed.

Rule 22 – If an illiterate depositor is unable to attend the Bank personally he may send the withdrawal order form or the letter of authority, as the case may be, with his left hand thumb impression thereon duly attested by two persons known to the Bank or a magistrate under his Court seal.

MODE OF WITHDRAWING MONEY BY CHEQUE

Rule 23 – In the case of cheque-operated accounts, withdrawals (subject to the provisions of Rule 36) are

allowed on the cheque forms supplied by the Bank. The Bank reserves its right to refuse payment of any cheque drawn otherwise. Cheque books will normally be issued to a depositor against an application signed by him on the Bank's requisition slip from the cheque book in his use.

Rule 24 – The Bank is at liberty to refuse payment of cheques that have been altered in any way unless the alteration is authenticated by the drawer under his signature. Cheques should be drawn in such a way as to prevent alteration after issue and the drawer's signature should be uniform with that on record at the Bank. It is essential that the cheque book be kept in a place of safety.

Rule 25 – The Bank will register instructions from the drawer regarding cheques lost, stolen, etc., but cannot guarantee depositors against loss in such case in the event of such a cheque being paid.

Rule 31 – The smallest sum that can be accepted at the time of opening a savings bank account is Rs. 20 and thereafter no deposit for less than Re. 1 will be accepted thereon. A savings bank account the balance of which falls below Rs. 20 may be closed at the Bank's discretion. In case of savings bank accounts where the facility of withdrawal by cheque is permitted a minimum balance of Rs. 100 shall always be maintained in the account.

Rule 33 – A savings bank account holder will not be permitted more than 50 debits on his account in a half-year. The debits will include all types of debits i.e. by cheques, transfers, letters, standing instructions or in any other manner. For accounts opened after the commencement of a half-year the number of permissible withdrawals will be calculated pro rata. In the case of a cheque, the date of payment, and not the date of the cheque, will be taken as the date of withdrawal for this purpose.

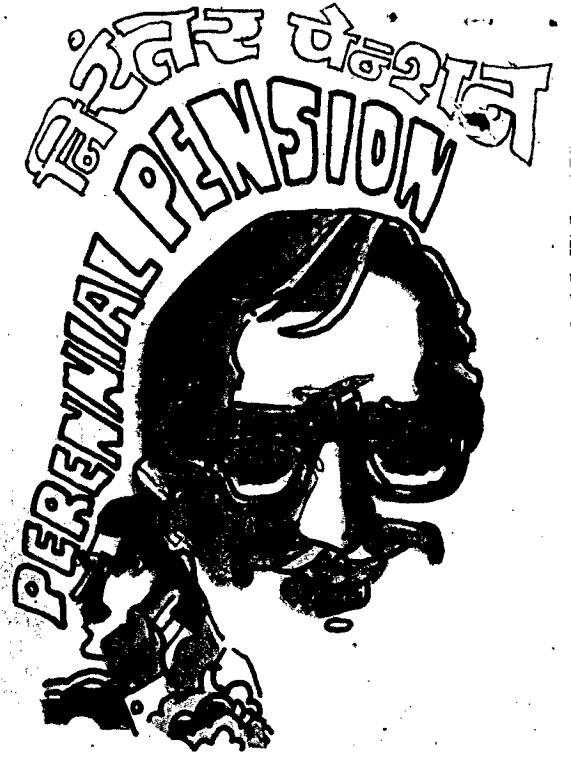
Rule 34 – A depositor cannot withdraw a smaller sum than one rupee, nor any sum which is not a multiple of Re. 1, unless it be to close the account in which case the entire balance at credit of the account will be withdrawn. In the case of a withdrawal by cheque, however, amounts need not be multiples of one rupee. No cheque should be drawn for amounts above Rs. 3,000 and below Rs. 5. A depositor desiring to withdraw an amount larger than Rs. 3,000 may do so by using a withdrawal order form.

INTEREST

Rule 37 – The current rate of interest allowed on deposits in savings bank accounts can be ascertained at the Bank. Any change in this rate, which is governed by the directives of the Reserve Bank of India, is notified through advertisement in the newspapers.




