May kindly see the letters dated 20.9.16 and 6.1.17, placed below (at flag 'A' and 'A-1') received from Sri Jagdish Kumar, Principal Judge, Family Court, Ghazipur by which he has submitted his property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(I) In the financial year 2014-15, Sri Jagdish's Gross Income is Rs.14,97,702/- from this amount, he has paid Rs.1,46,506/- against GPF, Rs.4800/- against GIS, Rs.1,63,600/- against Income Tax, Rs.2,45,928/- towards home loan. As such, total deductions /Savings/investment is Rs.6,06,803/-. The balance of his Saving Bank Account(s) decreased for Rs.56,949/- this financial year. Thus a sum of Rs.10,53;812/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letters dated 20.9.16 (flagged 'A') which was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the property statement for the aforesaid period from the part of officer.

In this connection it is submitted that Sri Jagdish has already been submitted his property statement upto the financial year 2013-14 which has been seen by Hon'ble Mr. Justice Ajai Lamba, Administrative Judge, Bulandshahr Judgeship which is at flag 'Z' and the said statement is at flag 'M'.
