May kindly see the letters, placed below at flag 'A', & 'A-I' received from Sri Jagdish Kumar, Additional District & Sessions Judge, Bulandshahr regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Jagdish Kumar had submitted his movable & immovable property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 through his letter dated 18-10-2014 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letters dated 20-02-2015 (flagged 'C').

Now, Sri Jagdish Kumar has submitted required informations alongwith required through his letter dated 08-04-2015 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the income from salary and other allowances is Rs.13,19,983/- and from this amount, Rs.2,28,193/- is deducted against GPF, Rs.1,440/- against GIS and Rs.2,07,123/- against Income Tax. The balance of his savings bank account (s) enhanced for Rs.26,099/- this year. As such, total deductions/ repayment is Rs.04,62,855/-. Thus, a sum of Rs.08,57,128/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2010-11.

(2) In the financial year 2011-12, the income from salary and other allowances is Rs.18,57,078/- and from this amount, Rs.5,68,934/- is deducted against GPF, Rs.2,840/- against GIS, Rs.3,18,627/- against Income Tax and Rs.60,360/- against house loan. The balance of his savings bank account (s) enhanced for Rs.45,271/- this year. As such, total deductions/ repayment is Rs.09,96,032/-. Thus, a sum of Rs.08,61,046/- was

therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2011-12.

(3) In the financial year 2012-13, the income from salary and other allowances is Rs.13,69,743/- and from this amount, Rs.1,96,404/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,30,000/- against Income Tax and Rs.1,81,080/- against house loan. The balance of his savings bank account (s) enhanced for Rs.1,16,131/- this year. As such, total deductions/repayment is Rs.06,28,415/-. Thus, a sum of Rs.07,41,328/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2012-13.

(4) In the financial year 2013-14, the income from salary and other allowances is Rs.14,20,310/- and from this amount, Rs.1,50,825/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,44,700/- against Income Tax and Rs.2,02,696/- against house loan. The balance of his savings bank account (s) enhanced for Rs.2,87,342/- this year. As such, total deductions/repayment is Rs.07,90,363/-. Thus, a sum of Rs.06,29,947/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Jagdish Kumar has already submitted his property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Ramesh Singh, the then Administrative Judge, Auriya Judgeship at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the same ^{firstly} through his letters dated 18-10-2014, as such, there is delay in submitting the same statements. The property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same ^{firstly} through his letter dated 18-10-2014 and as such, there is no delay in submitting the same statements for the years 2012-13 and 2013-14. He has not given any

reason for delay submitting the movable and immovable property statement for the financial year 2010-11 and 2011-12.

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12 2012-13 and 2013-14 alongwith letters dated 18-10-2014 and 08-04-2015 (flagged 'A' & 'A-I') of Sri Jagdish Kumar, Additional District & Sessions Judge, Bulandshahr be laid before Hon'ble Mr. Justice Ajai Lamba , Administrative Judge, Bulandshahr Judgeship for his Lordship's kind perusal and orders?
