
Sir,

4. Copy of 'Sale Deed' of the purchased flat.
5. Details of available funds with her by disclosing actual receipt in last ten years by her and of her dependent family members and annual expenses, which would include educational expenses on the dependent children. This should be submitted along with supporting papers.


