Earlier vide his letter dated 21.9.10 (at flag'B') Sri Saroj has submitted his property statement for the financial Years 2004-05, 2006-07, 2007-08, 2008-09 but he has not send his property statement for the financial year 2009-10 and also not mentioned his deduction from salary then a Court's letter dated 8.12.10 (at flag 'C') property statement for the financial year 2009-10 mentioning his deduction from salary and supplementary information about deduction of the aforesaid property statement to the Court.

In reply of aforesaid Court's letter, officer has submitted his required revised property statement to the Court vide his letter dated 21.12.10(at flag 'A').

In this connection it is submitted that Sri Pandey has already submitted the statement of his properties acquired/held for the financial year 2005-06

which was seen by Hon'ble Mr. Justice Sudhir Agarwal, Administrative Judge, Mau Judgship on 13.11.06 vide office note dated 1.11.06 at flag 'Z'.

Now all the property statement for the financial year 2006-07, 2007-08, 2008-09 and 2009-10(at flag I, II, III and IV) are in file. There is some delay in submission of property statement for the financial year 2006-07, 2007-08 which should be submitted in the financial year 2008-09 for which officer officer has regretted.
