May kindly see the letter dated 14.4.2015 (at flag 'X') of Sri Anil Kumar Pandey, Additional District and Sessions Judge, Gorakhpur by which he has submitted his supplementary informations regarding his GIS, PPF and Saving Bank Accounts of property statements for the financial years 2010-11, 2011-12, 2013-14 and 2014-15.

Earlier he has submitted his property statements for the financial years 2010-11, 2011-12, 2013-14 and 2014-15 vide his letters dated 21.1.2015 (flag 'A' and 'A-1') but in which he has not mentioned his Saving Bank Account at the end of the financial years and details of deductions i.e. GIS and payment of PPF amount in each financial years. Hence a Court's letter dated 9.3.15 (flag 'B') has been sent to the officer in this regard

In reply of aforesaid Court's letter, Officer has submitted his supplementary informations in this regard vide his letter dated 14.4.15 (flag 'X').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- (1) In the statement of movable and immovable property for the financial year 2010-11, Sri Pandey Gross Salary is Rs.13,49,322/- from this amount, he has paid Rs.3,35,081/- against GPF, Rs.4800/- against GIS, Rs.1,05,743/- against Income Tax, Rs.1,000/- against PPF, Rs.21,712/- against personal loan instt. As such, total deductions /Savings/investment is Rs.4,68,336/-. The balance of his Saving Bank Account(s) decreased for Rs.44,000/- Thus a sum of Rs.9,24,986/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.
- (2) In the statement of movable and immovable property for the financial year 2011-12, Sri Pandey Gross Salary is Rs.11,92,423/- from this amount, he has paid Rs.1,21,817/- against GPF, Rs.4800/- against GIS, Rs.1,67,041/- against Income Tax, Rs.2,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,20,658/-. The balance of his Saving Bank Account(s) decreased for Rs.25,000/-. Thus a sum of Rs.8,71,765/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.
- (3) In the statement of movable and immovable property for the financial year 2012-13, Sri Pandey Gross Salary is Rs.11,53,064/- from this amount, he has paid Rs.1,14,396/- against GPF, Rs.4800/- against GIS, Rs.1,07,872/- against Income Tax, Rs.1,000/- against PPF, Rs.43,200/- towards personal loan instt. As such, total deductions /Savings/investment is Rs.2,71,268/-. The balance of his Saving Bank Account(s) decreased for Rs.23,600/-. Thus a sum of Rs.9,05,396/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.
- (4) In the statement of movable and immovable property for the financial year 2013-14, Sri Pandey Gross Salary is Rs.11,67,567/- from this amount, he has paid Rs.99,844/- against GPF, Rs.4800/- against GIS, Rs.1,35,278/- against Income Tax, Rs.2,000/- against PPF, Housing loan, Rs.60,000/-. The balance of his Saving Bank

Account(s) enhanced for Rs.96,800/-. As such, total deductions /Savings/investment is Rs.3,98,722/-. Thus a sum of Rs.7,68,845/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 21.1.15^{22.01.15} (flag 'A' and 'A-1'). The Property Statements for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13 and Property Statements for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the Property statement for the financial year 2010-11 and 2011-12 from the part of the officer.

In this connection, it is submitted that Sri Pandey has already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Lucknow on Judgeship on 9.6.2011 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Anil Kumar Pandey, Additional District and Sessions Judge, Gorakhpur may kindly be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders ?
