May kindly see the office note dated 9.9.15 at flag 'X-2', regarding submission of statements of movable and immovable properties for the financial years from 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Anil Kumar Pandey, the then Additional District and Sessions Judge, Gorakhpur Presently Additional District and Sessions Judge, Shahjahanpur which was submitted before Hon'ble Mr. Justice Ramesh Sinha, Administrative judge, Gorakhpur for kind perusal and orders. On the aforesaid office note His Lordship's has been pleased to order as under:-

“Officer concerned has given incomplete property of statement as he has not given details of his gross income from salary and other sources and details of deductions and net income he had to meet his monthly expenditure for the financial year 2010-11, 2011-12, 2012-13 and 2013-14.

officer concerned is directed provide complete and correct information about the same immediately.

Further Officer concerned is directed to remain careful in future ensuring that the property statements is submitted within prescribed time..”

In compliance of above Court's Order, Court's letter dated 13.4.16 (flag 'L') has been send to the officer concerned with the request kindly to comply Court's order immediately

In reply of aforesaid Court's Order, officer has submitted his supplementary property statements vide his letter dated 3.5.16('N') for the aforesaid periods after mentioning his gross income from salary and other sources (he has mentioned that he has no income from other sources other than salary) details of deductions and monthly expenditure for the aforesaid financial years but in his details of deductions he has mentioned his personal loan deductions Rs.7200 to 10,000/- per month which should be required in particular, hence a Court's letter dated 2.6.2016('O') has been sent to the officer in this regard and also asked for payment of his LICs and PPF account, if he has possessed the same in that years.

In reply of aforesaid Court's letter, Officer vide his letter dated 25.7.2016(flag 'A') has stated that he has deposited an average of Rs.10,000/- per month in his personal loan deductions and further stated that he has no LIC policy and has not earned any amount from PPF account in these financial years.
