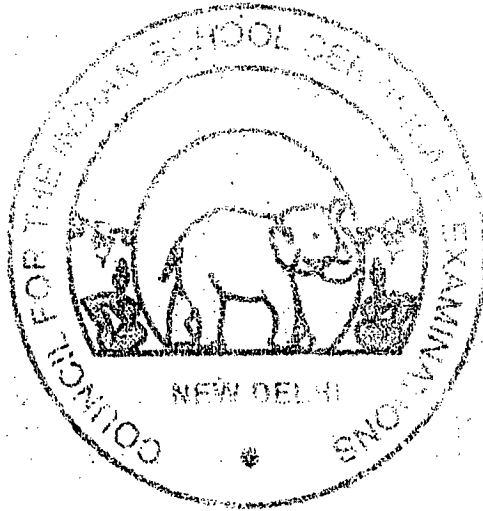



EXPLANATORY NOTE

I. EXTERNAL EXAMINATION

Attainment in a subject is indicated by a percentage mark.

II. INTERNAL ASSESSMENT
