May kindly see the letter, placed below at flag 'A' & 'A-I', received from Sri Narendra Kumar Pandey, Chief Metropolitan Magistrate, Kanpur Nagar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11 and 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

The statements for the aforesaid financial years was previously submitted to Hon'ble Mr. Justice Prakash Krishana, the then Administrative Judge, Kanpur Nagar Judgeship through office note dated 05-02-13 and again there after to Hon'ble Mr. Justice Vineet Saran, the then Administrative Judge, Kanpur Nagar Judgeship through office note dated 20-04-13 (both the notes placed below), but both the time the file/ office notes has been returned without Order. Now, again the matter is being submitted before present Hon'ble Administrative Judge, Kanpur Nagar Judgeship.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11 and 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the income from salary is Rs.14,80,411/- and from this amount, Rs.5,15,591/- is deducted against GPF, Rs.1440/- against GIS, Rs.1,96,113/- against Income Tax, Rs.50,100/- against LIC Premium, Rs.24,000/- against R.D., Rs.20,000/- purchased Infrastructure bond, Rs. 1,00,000/- deposited in SIP and Rs.1,44,000/- enhanced in his PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.2,69,369/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.13,20,828/-. Thus, a sum of Rs.1,59,583/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2010-11.

(2) In the financial year 2011-12, the income from salary is Rs.12,85,350/- and from this amount, Rs.1,57,831/- is deducted against GPF, Rs.2840/- against GIS, Rs.1,46,562/- against Income Tax, Rs.50,100/- against LIC Premium, Rs.24,000/- against R.D., R.20,000/- purchased Infrastructure bond, Rs. 2,40,000/- deposited in SIP and Rs.70,000/- deposited in his wife's PPF account in this year this. The balance of his savings bank account (s) enhanced for Rs.48,638/- (including interest). As such, total deductions/repayment/savings/ investment is Rs.07,59,971/-. Thus, a sum of

Rs.5,25,379/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2011-12.

However, it is pertinent to mention here that Sri Narendra Kumar Pandey has withdrawal a sum of Rs.1,30,000/- from his PPF account and a sum of Rs.4,52,855/- received form the maturity of his LIC policy.

In this connection it is submitted that last time, Sri Narendra Kumar Pandey had submitted his property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Ashok Bhushan, the then Administrative Judge, Ghaziabad on 09-11-2010 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the year 2010-11 and 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the same through letter dated 21-12-2012 and as such, there is no delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2010-11 and 2011-12 alongwith letter dated ²¹⁻¹²⁻¹² (flagged 'A') of Sri Narendra Kumar Pandey, Chief Metropolitan Magistrate, Kanpur Nagar be laid before Hon'ble Mr. Justice Krishna Murari, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
