The Rule 178 of the General Rules (Criminal) as framed by the
Hon'ble High Court of Judicature at Allahabad prohibits sending of record
directly to the court concerned in case the court of another State requisition
the record. For ready reference the relevant Rule 126 is reproduced herein
below:

"126 Requisition for records" When a record or a portion of a
record pertaining to a court in another state is required, the
requisition shall invariably be sent through the High Court. In no case
must it be sent to the court of fact. The Court summoning the record
or a portion of it must state whether it has satisfied itself that the
production of the original record or of a portion of it is actually
necessary.

Therefore, it is requested that in case the record is or is to be
produced before your court, then kindly send the requisition of concerned
court along with summons in the name of the Officer through the Hon'ble
High Court of Judicature at Allahabad.
