May kindly see the letters dated 26.12.2018 (flagged 'A' and 'A-1') by which Sri Ved Prakash Verma, Additional District and Sessions Judge, Varanasi has submitted his property statements for the financial years 2012-13, 2013-14, 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2012-13, Sri Verma income from Salary and other Sources is Rs.16,51,402/- (Rs.14,86,966/- is his gross Salary and Rs.1,64,436/- is from maturity of Mutual fund) from this amount Rs.93,967/- is deducted against GPF, Rs.4800/- against GIS, Rs.2,12,961/- against Income Tax, Rs.20,048/- against LIC, Rs.5,76,000/- against SIP of Mutual fund, Rs.50,000/- against SBI Life Insurance, Rs.20,000/- against IDFC Bond and Rs.50,000/- against PPF. As such, total deductions/ repayment/ Savings/investment is Rs.10,27,776/-. The balance of his Saving Bank Account(s) decreased for Rs.3,58,549/- this year against the balance of previous year. Thus a sum of Rs.9,82,175/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(2) In the financial year 2013-14, Sri Verma income from Salary and other Sources is Rs.14,94,789/- (Rs.11,24,789/- is his gross Salary and Rs.3,70,000/- is from Refund of registration fees by UP Avas Vikas Parishad) from this amount Rs.1,19,087/- is deducted against GPF, Rs.4400/- against GIS, Rs.1,23,150/- against Income Tax, Rs.20,048/- against LIC, Rs.50,000/- against SBI Life Insurance, Rs.19,710/- towards Housing loan and Rs.1,00,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.34,628/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.4,71,023/-. Thus a sum of Rs.10,23,766/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

(3) In the financial year 2014-15, Sri Verma's gross Salary is Rs.

13,56,322/- from this amount Rs.1,18,958/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,73,249/- against Income Tax, Rs.20,048/- against LIC, Rs.1,99,593/- towards Housing loan, Rs.35,000/- against PPF, Rs.50,000/- against SBI Life Insurance, Rs.10,000/- against STDR. As such, total deductions/ repayment/ Savings/investment is Rs.6,11,648/- . The balance of his Saving Bank Account(s) decreased for Rs.43,704/- this year against the balance of previous year. Thus a sum of Rs.7,88,378/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(4) In the financial year 2015-16, Sri Verma's gross Salary is Rs. 15,51,581/- from this amount Rs.1,30,187/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,59,700/- against Income Tax, Rs.20,048/- against LIC, Rs.2,33,244/- towards Housing loan, Rs.90,000/- against PPF, Rs.50,000/- against SBI Life Insurance. As such, total deductions/ repayment/ Savings/investment is Rs.6,87,979/- . The balance of his Saving Bank Account(s) decreased for Rs.17,549/- this year against the balance of previous year. Thus a sum of Rs.8,81,151/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The property statement for the financial year 2012-13, 2013-14, 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 26.2.2018 (flag 'A')^{2-A-1} The movable and immovable property statement for the financial years 2012-13 and 2013-14 was due to be submitted in third financial years 2014-15 i.e. on or before 31.3.15 and property statements for the financial years 2014-15 and 2015-16 was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is delay in submitting the aforesaid Property statement from the part of the officer for which officer has submitted that due his treatment of Cancer he has forget to submit the same and regretted.

In this connection it is submitted that last time Sri Veerma had submitted his property statement upto financial year 2011-12 which had been seen by Hon'ble Mr. Justice Devendra Pratap Singh, the then Administrative Judge, Meerut Judgeship on 7.1.2013, which is at flag 'Z' and the said statement

at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 of Sri Ved Prakash Verma, Additional District and Sessions Judge, Varanasi may kindly be laid before Hon'ble Mr. Justice B.
