May kindly see the letters dated 09.04.2018 (flagged 'A') by which Sri Ved Prakash Verma, Additional District and Sessions Judge, Varanasi has submitted his property statements for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2016-17, Sri Verma income from Salary and other Sources is Rs.16,05,253/- (Rs.15,32,030/- is his gross Salary and Rs.73,223/- is from maturity of Mutual fund) from this amount Rs.1,41,014/- is deducted against GPF, Rs.4800/- against GIS, Rs.1,75,700/- against Income Tax, Rs.2,33,244/- towards repayment of Housing loan, Rs.1,65,000/- against PPF, Rs.70,048/- against Insurances. The balance of his Saving Bank Account(s) enhanced for Rs.2,16,558/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.10,06,364/-. Thus a sum of Rs.5,98,889/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-17.

(2) In the financial year 2017-18, Sri Verma income from Salary and other Sources is Rs.16,03,922/- (Rs.15,90,957/- is his gross Salary and Rs.12,965/- is from maturity of STDR) from this amount Rs.1,08,000/- is deducted against GPF, Rs.4800/- against GIS, Rs.2,09,600/- against Income Tax, Rs.2,33,244/- towards repayment of Housing loan, Rs.1,24,000/- against PPF, Rs.70,048/- against Insurances. The balance of his Saving Bank Account(s) enhanced for Rs.3,08,640/- this year against the balance of previous year. As such, total deductions/ repayment/ Savings/investment is Rs.10,58,332/-. Thus a sum of Rs.5,45,590/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2017-18.

The property statement for the financial year 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 9.4.18 (flag 'A'). The aforesaid movable and immovable property statement was due to be submitted

in the financial year 2018-19. As such there is no delay in submitting the aforesaid Property statement from the part of the officer.

In this connection it is submitted that last time Sri Veerma had submitted his property statement upto financial year 2015-16 which had been seen by Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Varanasi Judgship on 22.5.18, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2016-17 and 2017-18 of Sri Ved Prakash Verma, Additional District and Sessions Judge, Varanasi may kindly be laid before Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Varanasi Judgship for His Lordship's kind perusal and orders?
